Report Highlights:

Korea has issued its annual list of adjustment tariffs and voluntary tariff rate quotas (TRQs) for certain agricultural products for calendar year 2022. Korea's 2022 tariff adjustments were relatively unchanged from the previous year; however, expanded TRQ's in a handful of agricultural commodities will increase opportunities for U.S. agricultural exports, particularly in feed grains and food ingredients.

Executive Summary:

Adjustment Tariffs & Voluntary TRQs Announced for 2022

On December 28, 2021, the Ministry of Economy and Finance (MOEF) announced an updated list of adjustment tariffs (Table I) and voluntary tariff rate quotas (TRQs) for certain agricultural, forestry and fishery products (Table II) that are effective through calendar year 2022. These adjustment tariffs and TRQs are part of a special program run by MOEF to assist domestic industries. According to the Ministry, the voluntary TRQs for agricultural commodities are intended to assist the domestic livestock industry by reducing input costs at a time of inflationary pressures in the food and ag sectors. As such, these TRQs are focused primarily on feed grains.

In 2022, MOEF will maintain adjustment tariffs on 13 selected agricultural and fishery items. The items are unchanged from 2021. See the related report in the <u>GAIN System</u>: KS2021-0009. Tariffs are set in consideration of price differences between domestic and imported goods, market share, and tariff differentials within similar product categories. Tariffs identified in Table 1 (parboiled rice, Chinese vermicelli, oak mushroom, plywood, frozen squid, and frozen Alaskan Pollack) are justified through MOEF's determination that competing domestic industries continue to require protection.

MOEF also manages its 2022 voluntary TRQs with a goal of achieving domestic price stabilization, improving industrial competitiveness, and reducing input costs for domestic livestock producers. Notable changes to Korea's 2022 voluntary TRQ schedule include the reintroduction of wheat bran, a raw material for livestock compound feed and maize for food processing. Both items will be subject to a zero percent tariff rate. Additionally, MOEF prepared TRQs for seven egg items totaling 37,260 metric tons at a zero percent tariff (Table III) during the first six months of 2022. This action aims to stabilize the local egg market that has been suffering from a recent wave of avian influenza outbreaks in Korea's poultry sector and inflationary table egg prices to consumers. The egg TRQ is set to expire at the end of June 2022.

This year, five commodities received additional volume allocations beyond their 2021 quota. Increases were applied to manioc chips, maize for feed, fodder roots and other vegetables, sugar, and other preps for feed. Conversely, TRQs for cotton seed for feed, lactose, lactose syrup for feed and brewing waste for feed have been removed from this year's voluntary list.
