II. Key Market Information

- 1. U.S. exports of food and agricultural products to the Gulf Cooperation Council (GCC) countries covered by ATO-Dubai, the GCC-5¹ reached a record level of \$300 million in 1998. Countries in the GCC import a greater percentage of U.S.-produced consumer-oriented food products than bulk or intermediate agricultural goods. This is a marketplace highly dependent on food imports, and U.S. products enjoy a strong reputation. In addition to meeting the demands of the markets here, there is a constant flow of food product and agricultural commodity reshipment to CIS countries, Iran, India and East Africa.
- 2. The 1999 edition of ATO Dubai's American Food Directory is available. This annual publication lists suppliers and importers of U.S.-origin food products to the GCC-5.
