### **Report Highlights:**

On February 28, the Algerian Inter-professional Office of Cereals (OAIC) launched a public call to register grain and pulse traders on its supplier shortlist. The shortlist application process is typically opened once every several years. The latest call for the shortlist application is intended for suppliers of cereals (common wheat, durum wheat, barley, rice), pulses (chickpeas, beans, lentils) and cereal seeds and pulse seeds. The shortlist application will close on 14 April 2023.

On February 28, the El Moudjahid newspaper published a public call for applications for the Algerian Inter-professional Office of Cereals (OAIC) tender short list. The OAIC is a state agency that procures grains on the domestic as well as international markets for sale and distribution in Algeria. In order to participate in the OAIC tender process, the suppliers must be registered on its shortlist. The shortlist application process is typically opened once every several years. The latest call for shortlist application is intended for suppliers of cereals (common wheat, durum wheat, barley, rice), pulses (chickpeas, beans, lentils) and cereal seeds and pulse seeds.

The registration process will be open for 45 days from the date of the announcement. As such, the tender will close at noon, Algiers time, on April 14, 2023. During that time, suppliers must submit a paper application to the OAIC. The application may be submitted in English, French, or Arabic. Note that all documents must be notarized. Suppliers already registered on the OAIC shortlist must submit a new application. The items that must be submitted include:

- A declaration of candidacy; (per ANNEX II in the official journal publication N017 of March 16, 2016, please see copy of the declaration of candidacy and unofficial translation in the Annex of this report;
- A declaration of probity (integrity), (per ANNEX I in the official journal publication N017 of March 16, 2016, please see copy of the probity declaration and unofficial translation in the Annex of this report;
- The documents relating to the powers authorizing the persons to hire the candidate; (employment contract);
- Balance sheets and accounts results for the last two financial years (2020-2021) duly certified by an auditor and bank references;
- Company statues;
- Business (trade) registers;
- Tax references:
- The criminal record (less than three months) of the legal representative(s) of the company (or of all the members of the same solidarity group);

Notice of International Call for Pre-selection N01/2023 for the Expansion of the Supplier file (SHORTLIST) of cereals (common wheat, durum wheat, barley, rice), pulses (chickpeas, beans, lentils) and cereal seeds and pulse seeds) of the Algerian Interprofessional Office of Cereals (OAIC-EPIC)

As part of the expansion of the short list (supplier file), the Algerian Interprofessional Office of Cereals (OAIC-EPIC) is launching an international call for preselection for the expansion of its cereal's supplier file (short list) for (soft wheat, durum wheat, barley and rice), pulses (chickpeas, beans, lentils, etc.) and seeds (cereals and pulses).

This notice for pre-selection is intended for operators organized in the form of commercial companies acting as producers or usual suppliers (traders) of the above-mentioned products, not registered in the list of economic operators prohibited from participating in the public markets.

Operators currently appearing in the OAIC supplier file and wishing to take part in this preselection must also comply with the provisions of this notice of call for preselection.

Candidates for this notice of call for preselection are required to send, within forty-five (45) days from the first publication of this notice in the national press, their application files consisted of the following documents:

- A declaration of candidacy; (according to the model in the official journal N017 of March 16, 2016);
- A declaration of probity, (according to the model in the official journal No 17 of March 16, 2016);
- The documents relating to the powers authorizing the persons to hire the candidate;
- Balance sheets and accounts results for the last 02 financial years (2020-2021) duly certified by an auditor and bank references;
- Statutes for companies;
- Business (trade) registers;
- Tax references;
- The criminal record (less than 03 months) of the legal representative(s) of the company (or of all the members of the same solidarity group);

Any other document that can help the Algerian Office Interprofessional of Cereals (OAIC-EPIC) to better identify the operator and assess his capacities and qualifications.

These documents must be drawn up in Arabic, French or English in copies certified by the authorized authorities of the country.

The application must be inserted in a sealed envelope, indicating the denomination of the candidate, the reference and the object of the notice of appeal as well as the mention "application file".

This envelope will be put in a second sealed and anonymous envelope, bearing the mention:
