#### **Report Highlights:**

Revised KS4018 on April 9,2004. Revised section: PS&D attached.

Raw sugar imports are expected to increase marginally in MY 2004/05 in response to improving demand from the soft drink sector and continued strength in refined sugar export demand from China. Increasing international corn prices could reduce the competition Korean sugar refiners face from high fructose corn syrup manufacturers in MY 2004/05.

#### Section I. Situation and Outlook

Sugar cane and sugar beet are not produced in Korea. However, Korea produces about 1.25 – 1.28 million metric tons (MMT) of refined sugar annually from imported raw cane sugar. Korea's raw sugar imports are led by three major refiners; CJ, Samyang and TS. The three leading importers accounted for over 90 percent of annual raw sugar imports. The remaining 10 percent is imported by the feed sector for lysine production. According to the Korea Sugar Association (KSA), Korea consumed about 74 percent of refined sugar domestically and exported the remainder in calendar year (CY) 2003.

#### Refined Sugar Consumption

Korea's refined sugar consumption is forecast to increase from 1.26 MMT in marketing year (MY) 2003/04 (September –August) to 1.27 MMT in MY 2004/05. The soft drink industry, a major demand factor for refined sugar in Korea, experienced a 3 percent sales decrease in CY 2003 reflecting dampened sugar consumption caused by the slow economy and cool summer weather. However, increased refined sugar exports to China and demand from the lysine production sector offset the decreased refined sugar consumption in domestic soft drink section in CY 2003. Korean soft drink consumption is expected to increase 3 – 4 percent in CY 2004 along with an expected economic recovery in the second half of CY 2004.

#### Trade

In MY 2004, Korea's raw sugar imports are expected to continue an upward trend amounting to 1.61 MMT. Increased imports will be driven by high demand for Korean refined sugar in China and a rebound in the domestic soft drink industry. Korea imported 849,820 MT of raw sugar from Australia in MY 2002/03; a 35 percent increase from MY 2001/02. Imports from Australia accounted for 53 percent of Korea's total raw sugar imports in MY 2002/03. Australian and South African raw sugar imports, along with lower quality imports from Guatemala and Brazil, will likely remain the primary sources of supply for Korean refiners. Raw sugar imports from Guatemala and Brazil decreased from 554,802 MT in MY 2002 to 392,420 MT in MY 2003.

Raw sugar imported by the Korean feed industry increased to 150,000 MT in CY 2003 from 140,000 in CY 2002 to meet demand for lysine exports to South-East Asian countries.

Korean refined sugar exports increased by 4 percent to 325,927 metric tons (MT) in MY 2002/03 from 314,297 MT in MY 2001/02. The primary export market for Korean refined sugar is China. Exports to China jumped 34 percent to 100,185 MT in MY 2003 from 74,819 MT in MY 2002. Increased exports to China offset reduced exports to Hong Kong and the Philippines. Hong Kong and China covered 68 percent of the Korean refined sugar exports in MY 2003. The Korean sugar industry expects China to increase demand for Korean refined sugar steadily as more Chinese diets shift to more processed foods and beverages in response to improved living standards.

#### Stock

According to local refiners, 27 – 30 days of raw sugar stocks, amounting to about 110,000 MT, are usually on hand for the production of refined sugar. The domestic retail price of refined sugar is 666 Korean Won (KRW) / kilogram (Kg) (US\$ 0.58 / Kg). Retail sugar prices have been steady since July 2002. Increased international future prices for raw sugar and increased freight costs will likely cause the Korean refined sugar industry to raise retail prices in the second half of CY 2004.

**HFCS** 

HFCS, a key substitute for refined sugar is priced competitively against refined sugar in Korea. According to the local HFCS industry, HFCS is available at 450 - 460 KRW / Kg (US\$ 0.39 - 0.4 / Kg) in Korea. The soft drink industry consumes more than 80 percent of total HFCS production with the remainder going into confectionary and pharmaceutical products. Within the Korean soft drink industry, carbonated soft drinks accounted for the main consumption of HFCS. Carbonated soft drink consumption decrease 7 percent in CY 2003 due to cool summer weather and reduced domestic consumption stemming from the slow economy. Similarly, HFCS production decreased as well. The HFCS industry is expected to increase production in MY 2003/ 04 along with the anticipated rebound of domestic consumption driven by a strengthening local economy.
