## **Argentina Increases Tariffs on Food Products**

## **Report Highlights:**

Argentina increased the tariffs on most high value consumer ready food products to 35 percent on April 10, 2001 as part of a new economic recovery plan. The tariffs on most fruits and vegetables were increased to 25 percent, while the tariff on cat and dog food increased to 20 percent (from 16.5 percent).

The Argentine Government increased the import tariffs on most consumer products to 35 percent (both agricultural and non-agricultural) as part of a new economic policy to stimulate local production (the tariffs on most capital goods were also reduced to zero). The tariffs on fruits and vegetables were increased to 25 percent (with some exceptions such as almonds which remained unchanged), while the tariff on cat and dog food increased to 20 percent (up from 16.5 percent).

The new tariffs were established at the maximum allowed under World Trade Organization rules, where Argentina has bound (ceiling) tariffs for most products of 35 percent (20 percent in the case of pet food). The higher tariffs are not applicable to imports from other Mercosur countries (Brazil, Paraguay and Uruguay), nor are they applied to imports from Andean Pact countries.

Argentina received a waiver from Mercosur's common external tariff shortly after announcing the increased tariffs, under the understanding that the tariff increase would not be permanent (beyond the end of 2002). Tariffs on products entering other Mercosur countries did not increase.

The increases will raise the tariffs on approximately half of U.S. food and agricultural exports to Argentina, which according to Argentine Government statistics totaled \$126 million in 2000 (excluding fiber and forestry). Tariffs prior to the recent increase were generally between 13 and 20 percent.

The 35 percent tariff applied to some chocolate confectionery products (1806 31 20 and 1806 32 20) is currently in excess of the WTO bound tariff level, an issue which FAS/Buenos Aires has raised with the Argentine Government. According to the official response, the WTO bound tariff takes precedence over the new tariff increase and customs officials are only allowed to collect the bound tariff of 25 percent. Exporters should contact the Agriculture Section in the US Embassy if Argentine Customs charges the higher duties on these products.

The new tariffs were published in Resolution ME No. 27/2001 dated April 10, 2001 (which amended Resolution ME 8/2001 (BO 27/03/01)). The attached tables list the tariff increases in two different tables. Table 1 includes the products where the tariff was increased to between 20 and 26.6 percent. Table 2 includes all products where the tariff was increased to 35 percent.

Please note that the product descriptions are informal translations and exporters should consult with Argentine customs officials for the official description or contact the Agriculture Section in the US Embassy (agbuenosaires@fas.usda.gov) for a more complete description. Tariff descriptions at the 6-digit level under the Harmonized System are the same in both the US and Argentina, while descriptions generally vary at the 8-digit level.
