Report Highlights:

Favorable weather conditions in 2000 resulted in increased output, compared to the 1999 harvest. However, due to the relatively large stocks on hand from the previous season and lower prices on the international market, total peaches processed in 2000 were 48,000 MT lower than the quantity processed in 1999. Exports of canned peaches during CY2000 totaled 267,500 MT, a 3% increase relative to 1999 exports (figure subject to revision). Peach withdrawals in 2000 totaled 204,000 MT, a slight increase over the 1999 level.

SECTION I: SITUATION AND OUTLOOK - NARRATIVE

CANNED PEACHES

Production

Weather conditions through June of 2000 were about normal with somewhat lower than normal precipitation. Because of the heavy set, fruit size was relatively small. High July and August temperatures resulted in ripening a week earlier than expected and adversely affected the early varieties of cling peaches, which were either left on the tree or taken to the withdrawal pools. Later varieties were of good quality with high Brix and good color (these varieties represent approximately 60% of total clingstone production). A number of plants started processing in mid July but, as of early August, they had not gone into full production. Processing was terminated by mid September in most plants. Total tonnage of cling stone peaches processed for canned peaches for the year 2000 is presently estimated at 308,000 MT as compared to 356,000 MT the prior year. This lower tonnage processed in the 2000 year is due to the relatively larger stocks on hand from the previous season and the lower prices offered on the international market. The stocks level for 1999/2000 was unusually high (102,000 MT) because the volume of peaches delivered to processors in 1999 totaled 356,000 MT. Present revised peach crop production estimates for the 1999 and 2000 years are as follows:

Peach production was greater in 2000 than in 1999, but less fruit was canned. The lower processed volume in 2000 was due to the large stocks carry over from the prior year and the low international prices of canned peaches. The volume of exports, domestic fresh consumption and waste were all higher in 2000 than in 1999 because of increased availability. As usual, exports and domestic consumption are freestone peaches while canned peaches are exclusively of the clingstone variety.

The utilization of the 1999 and 2000 peach crops based on more recent available data are revised as follows:

^{*}The maximum total allowable withdrawal quantity of peaches within the EU countries was not to exceed 40 percent of the total marketed tonnage in 1999 and this was further reduced to 30 percent for the 2000 season. This is in line with EU Reg. No2200/96 of Oct. 28, 1996, which established the gradual reduction of quantities to be withdrawn.

The quality of packed products this past season was good. A total of 26 factories canned peaches in the 2000 season, as against 27 in the prior season. The minimum price to growers in 2000 based on EU Reg. 1237/2000 of June 14, 2000 was set at 28.368 EURO/100 kgs net the same as in 1999 (about \$0.25 /kg). The rate of exchange during the processing period, July through September, averaged about 337 drachmas per 1 EURO. The processing aid to canners (under the same regulation) was 4.134 EURO/100 kgs net (fruit plus syrup), resulting in a final cost to processors of about 76 drachmas/kg (\$0.20/kg). The comparable price for the previous season was about 65 drachmas (\$0.21/kg).

Consumption

The annual domestic consumption of canned peaches, excluding quantities used in the production of canned fruit mixtures, confection and other purposes is estimated at close to 6,000 MT. It should be noted that, in the case of canned peaches, the domestic consumption figures shown in the PS & D table include quantities of diced peaches used in the production of canned mixtures. Over 80 percent of the domestic consumption of canned peaches is offered in retail sizes and the balance marketed in institutional can sizes of 3 kgs (A9 and A10) and 5 kgs (A12) cans.

Stocks

Industry sources report that stocks of canned peaches on June 30, 2000 totaled about 100,000 MT (5 million cases) due to the larger1999 pack. Of this total amount about 67,000 MT (3.5 million cases) were sold but not shipped, and the balance was unsold. It is believed that all 1999 crop stocks of canned peaches had been sold by Dec. 31, 2000. It is further indicated that over 50 percent of the 2000 canned peach crop, which amounted to about 397,000 MT (19.5 million cases), had been sold or committed by Dec. 31, 2000. Processors were able to move this volume relatively quickly by setting for narrow profit margins.

Trade

Export / import data for the 2000 CY are not yet available from the NSS. As of early March, industry sources indicate that the entire tonnage of 1999 crop stock has been sold and that 75 to 85 percent of the 2000 production has been shipped or committed. As shown in the following table the actual ex-factory prices for canned peaches—started at very depressed levels, barely covering production costs. The situation improved slightly as the season progressed, but still remained at low levels leaving only marginal profits.

At present, processors are not eager to sell their stocks on hand, anticipating some price increases later in the season.

The sale prices of canned peaches ex-factory in mid January 2001 to the U.S. in A9 and A10 cans (drained weight of 1.8 and 2.0 kgs respectively) were quoted at \$14.5 and \$16.5 per 6 can/case.

Policy

With respect to peaches, the GOG continues to implement policies based on EU guidelines. The EU issued Reg. No 2699/2000 dated Dec. 4, 2000 by which it revises a) Reg. No 2000/96 for the common organization of marketing of fruits and vegetables, b) Reg. No 2201/96 for the common organization of marketing for the processed fruits and vegetables and c) Reg. No 2202/96 for the support of certain citrus growers. This new regulation establishes a national quota (ceiling) for each member country as opposed to a community quota as was used up to 2000. In addition, this quota is established for fresh fruit only and not for processed product (fruit plus syrup/juice). In cases where a country exceeds the quota ceiling, the price support for the growers will be reduced by the percentage of over-production in the following year.

The price support as of this year is granted directly to the growers, who negotiate through a growers association or directly with the processors for the establishment of the market price. The processing aid that used to be granted through the 2000 season to the processors is abolished as of the 2001 year. The price support to growers for peaches to be canned as of 2001 season is set by the same regulation at 47.70 Euro per Metric Ton. At the present rate of exchange (340.75 drachmas per 1 Euro) the actual grower support price is 16,254 drs/kg. Prerequisite for this payment is a signed contract with a processor. According to peach sector contacts, the processors signed one year contracts with the growers prior to the beginning of the MY. The price is negotiated annually and does not include the support price. Supplemental contracts may be signed, specifically for peaches, not later than August 15. The EU announces the support price for peaches every year by April 30.

As of Jan. 1, 2001 the quantities of peaches and nectarines withdrawn were set at no more than 20 percent of the fruit marketed by the groups of growers. This percentage will be further lowered to 10 percent as of Jan. 1, 2002. The total quantity of fruit marketed is calculated for this regulation as total fruit sold on the domestic market (fresh or for processing) plus total fruit exported.

The withdrawal price for 2001 is set at 11.72 Euro per 100 kgs net, which corresponds to 39.94 drs/kg at the present rate of exchange compared to 43.00 the prior year. The quantity of peaches withdrawn during the 2000 season totaled 204,000 MT as compared to 203,000 MT in 1999.

Interest rates quoted at present by the Agricultural Bank of Greece for short and medium term loans to processors/exporters are 7.5 and 8.5 percent respectively. These rates became effective in early January 2001 and may be further lowered by up to 2 percentage points depending on the customer's rating. The present rate of inflation runs at about 3.5 percent as compared to about 2.7 percent last year.

There are no direct export subsidies for canned peaches. The custom tariff rates for imports from third countries, including the U.S., have remained the same as those shown on page 5 of our GR-0023 of Oct. 2, 2000, and the value-added tax continues to be levied at the 8 percent rate.

No changes in import regulations have taken place in recent years. The special rebate to cover part of the cost of sugar in the case of exports to third countries, established by EU Reg. No 426/86, continues to be in effect. This special rebate is continuously adjusted. The special rebate is paid irrespective of the cost of sugar based on the amount used in the canned product. As of early January 2001 the rebate stands at 40.59 Euro per 100 kgs of sugar, provided the sugar is imported. This corresponds to 138.31 drs/kg (\$0.384/kg).

CANNED FRUIT MIXTURES

Production

Early indications are that the 2000/01 production of canned fruit mixtures will be close to 14,000 MT. The considerably larger tonnage produced this year is mainly due to demand from U.S. market (resulting from the closure of the Tri-valley facility in California) as well as to increased demand from the Japanese market. The 1999/2000 production is presently estimated at 9,100 MT.

This year, over 50 percent of canned fruit mixtures are packed in institutional 3 kgs cans (A9 and A10) with the balance in consumer size packs of ½ kg and 1 kg cans. The U.S. market absorbs mostly canned fruit mixtures in A10 cans. The volume of canned diced peaches utilized by processors in the 2000/01 season for the production of fruit mixtures is estimated at about 7,500 MT (basis half fruit plus syrup). The corresponding volume of fresh pears was about 6,900 MT. There were basically five plants that processed fruit mixtures in 2000/01 season, of which three processed over 90 percent of the total pack. The minimum price to growers for Williams and Rocha pears used in processing (set by EU Reg. No1285/2000 of June 19,2000) remained the same as last year at 35.552 Euro per 100 kgs net. (about \$0.32/kg).

As was the case for canned peaches export/import data for the 2000 CY are not yet available. At present (early March), industry sources indicate that the entire 2000/01 production is already committed and there will be only negligible stocks by the end of the marketing year. The total ex-factory export prices for good standard and standard quality canned fruit mixtures this season for 2000/01 product were as follows per 24/1kg case:

As regards the ex-factory price of a case of 6-A10cans of good standard quality for the U.S. market ranged in Jan.-Feb. 2001 between \$14.5 and \$16.5.

Policy

The peach and pear portions of canned fruit mixtures, which account for about 80 percent of the pack content (peaches 45% and pears 35%) are covered by the new EU policies. With regard to peaches, this information is covered in detail in the canned peach section of this report. Grower support prices for Williams and Rocha pears are set by EU Reg. No 2699/2000 of Dec. 4, 2000 at 161.70 Euro per MT net weight, which corresponds to 55.10 drs/kg. As in the case of canned peaches, as of the 2001/02 year, there will be no processing aid to pear packers. The EU quota for total EU production of canned William and Rocha pears as of the 2001/02 season was set at 104,617 MT of fresh pears (net wt.). At the same time, a specific national quota was set for each member country, which in the case of Greece is set at 5,155 MT. In case that the national quota is exceeded, the support price will be lowered by the percentage that the quota was exceeded by the following year.

The 2000/01 withdrawal price (July 2000 through August 2001) for pears, as set by EU Reg. No. 2200/96 of Oct. 28, 1996, was 9.10 Euro per 100 kgs net. This price is further lowered to 8.75 Euros per 100 kgs net for the 2001/02 season by the same regulation. The amount of pears withdrawn during the 2000/01 year was negligible. The custom tariffs for canned mixtures imported from third countries, including the US, have remained the same as those shown on page 15 of our report GR-0023 of October 2, 2000, while the value added tax continues to be levied at the 8 percent rate. Import regulations as well as sugar rebates for exported canned mixtures to third countries, are identical to those covered in the canned peaches section of this report.

The exchange rate of Euros to drachmas for 2000 averaged 336.640 drachmas per 1 Euro while as of

January 1, 2001 the rate of exchange was set at 340.75 drachmas per 1 Euro.

CANNED APRICOTS

Production

The 2000 apricot production has been revised from the earlier estimate of 80,000 MT to 75,000 MT, while the 1999 apricot crop is estimated at 80,000 MT (final). Apricot production and exports are returning to normal levels as the fruit quality was better in 1999 and 2000, which brought more fruit to processors for canning. The 2000 deliveries of apricots to processors for canned apricots reached 17,300 MT and the overall quality was satisfactory. Yields of canned apricots obtained in 2000 averaged 17.56 kgs of fresh apricots per 24/1 kg can/case compared to 16,88 kgs in 1999 due to smaller size fruit. There were only 7 plants that processed apricots in syrup/juice or water in 2000 as against 5 the prior year. The average price that the processors paid to growers during the 2000 season ranged between 50 and 80 drs/kg (\$0.18 to \$0.23/kg). An additional 20drs/kg (\$0.06/kg) to cover costs of transportation, loading and unloading had to be paid by processors since the processing plants are located in Northern Greece, while apricot production is centered basically in Peloponnesus (Southern Greece). The final price that the processors paid in 1999, including cost of fruit transportation and handling, ranged between 90 and 110 drs/kg (\$0.29 and \$0.36/kg).

Trade

As was the case for canned peaches and canned fruit mixtures, export/import data for canned apricots for the 2000 CY are not yet available. At present, there are very small stocks on hand and these are committed. Ex-factory prices of canned peeled apricots this past season were provided in our report GR-0023 of Oct.2, 2000.

Policy

Canned apricots, as mentioned in past reports, were not covered by EU policies (minimum price to growers and processing aid to packers up to the 2000 season). Only withdrawal prices are established by EU. Based on EU Reg. No 2200/96 of Oct. 28, 1996 the 2000 apricot withdrawal price was set at 16.06 Euros per 100 kgs net that the corresponds to 53 drs/kg (\$0.145/kg), while for the 2001 year it is set at 15.12 Euro per 100 kgs net, which corresponds to 51.50 drs/kg (\$0.141/kg). The quantities withdrawn during the 2000 season totaled 2,120 MT as against 9,200 MT the prior year.

The custom tariff rates for canned apricots imported from third countries, including the U.S. which have been lowered as of July 1, 2000 and which are in effect at present are as follows:
