Report Highlights:

Total Turkish cotton production is expected to be about 500,000 MT(3.3 million bails) in MY 2010, about thirty percent higher than the previous year. Domestic consumption for MY 2009 is now estimated at about 1.25 MMT(5.7 million bails).

Executive Summary:

The MY2010 cotton crop benefited from favorable weather conditions and total domestic production is expected to be about 500,000 MT (3.3 million bails), thirty percent higher than the previous year. Domestic consumption for MY 2009 is now estimated at about 1.25 MMT(5.7 million bails). Increased domestic and export demand caused MY 2009 cotton imports to increase to 866,245 MT (3.9 million bails) in the first eleven months of the marketing year. Imports from the United States were 420,000 MT (1.9 million bales) during the same period. High U.S. prices had an adverse effect on exports. The GSM-102 Credit Guarantee Program continues to play an important role in U.S. exports to Turkey.

Production

Favorable climate conditions and high temperatures in all cotton growing regions are reported. MY 2010 cotton area and production are estimated to be about 330,000 hectares and 500,000 MT (2.3 million bails) due to larger than anticipated planting as a result of high world cotton prices.

Consumption

MY 2009 domestic cotton consumption is now estimated to be about 1.25 MMT (5.7 million bails). The Turkish textile industry had higher than expected orders during the first half of the marketing year. According to available trade estimates, Turkish textiles and ready-to-wear item exports were up twenty-four and eight percent respectively during the first six months of 2010. Sources indicated that high world cotton prices increased the cost of production for the far-eastern producers. Turkish producers who were covered by long term cotton purchasing contracts were slow to increase prices, and so managed to increased sales to mostly European countries. However, a decline in the value of the Euro and increase in the value of the U.S. dollar is also a source of concern for Turkish textile manufacturers since the Turkish textile industry buys its raw materials on a U.S. dollar basis and sells finished products to EU member countries on a Euro basis.

Trade

According to available information, Turkey imported about 866,245 MT (3.97 Million bails) of cotton during the first eleven months o MY 2009, of which 419,567 MT (1.9 Million bails), or forty-eight percent is U.S. cotton. High U.S. cotton prices causes this amount to be lower than usual. Greece, the CIS countries, Brazil and India were the other suppliers to Turkey. The GSM-102 credit guarantee program continues to play an important role in U.S. cotton sales to Turkey.

Turkish cotton exports during the same period were about 12,600 MT (57,800 bails), about 6,160 MT of which was to Turkish free trade zones, which means that some of this cotton may be

imported back into the country. Turkey also exported about 19,500 MT of cotton for medical use during the same period.
