Report Highlights:

On December 17, 2019, Russia notified the World Trade Organization (WTO) of draft amendments to the Unified EAEU Veterinary Requirements and respective Unified EAEU forms of veterinary certificates via G/SPS/N/RUS/176. The notified measure should bring some EAEU requirements for bovine semen, sheep and goats, and pork in line with the Codex recommendations. This report contains an unofficial translation of the notified document. The public comment period for the draft will close on February 15, 2020. General Information

The Eurasian Economic Commission (EEC), which is the regulatory body of the Armenia-Belarus-Kazakhstan-Kyrgyzstan-Russia Eurasian Economic Union¹ (EAEU), published the following draft documents on its website:

- On Amending the Unified Veterinary (Veterinary and Sanitary) Requirements for Goods Subject to Veterinary Control (Surveillance)
- On Amending Forms of the Unified Veterinary Certificates for Controlled Goods Imported into the Customs Territory of the Eurasian Economic Commission from Third Countries

On December 17, 2019, Russia notified the World Trade Organization (WTO) of the draft documents via <u>G/SPS/N/RUS/172</u>. The public comment period for the draft will close on February 15, 2020. Interested U.S. parties are encouraged to share their comments and/or concerns with USDA's enquiry point (<u>us.spsenquirypoint@fas.usda.gov</u>). For potential inclusion in the U.S. official position, please send your comments by February 3, 2020.

According to the notification, the drafts lift certain requirements on imports of bovine semen, sheep and goats and pork meat into the territory of the Eurasian Economic Union. In particular, the proposed measure would allow collection of bovine semen from bulls vaccinated for bovine viral diarrhea, cancel the required testing for adenomatosis for sheep and goats, and delete the attestation of freedom from porcine reproductive and respiratory syndrome on the premises. The EAEU explanatory note for the drafts stresses the measure is necessary in order to bring the EAEU veterinary requirements in line with the Codex recommendations. Please find below an unofficial English translation of the proposed measure.

- 1. To amend the forms of the unified veterinary certificates for controlled goods imported into the customs territory of the Eurasian Economic Commission from third countries, approved by decision of the Customs Union Commission No. 607 of April 7, 2011, in accordance with the attachment.
- 2. To establish that the forms of veterinary certificates issued in accordance with decision of the Customs Union Commission No. 607 of April 7, 2011, prior to entry into force of the present decision, shall be used through December 31, 2020.
 - 3. The present decision shall take effect after 30 calendar days from its official publication.
