Dried Fruits and Nuts Market Brief - Slovakia

Summary

Virtually all dried fruits and nuts on the Slovak market are imported and the United States is a significant supplier, mainly of almonds, raisins, prunes and peanuts. Due to very a low level of domestic production, there are no official statistics on these commodities and there is little market protection or regulation. Prices are determined by prices in exporting countries although discounts are offered to large hypermarkets.

Production and Processing

Slovakia has a suitable climatic conditions for growing of walnuts, hazelnuts, apples, pears and apricots. However, production is quite limited. Due to the absence of large processor/dryers almost all apples, pears and apricots are sold either fresh or to canning companies for further processing. Very small amount of dried fruits (mainly apples) are processed locally (so called ,,garage production"). Walnut trees are quite popular in gardens but production is mainly for household consumption rather than for market sale.

Trade

Since the production of nuts and fruits is very limited almost all dried fruits and nuts are imported from abroad. Recently, United States has been significant exporter to Slovakia of dried fruits and nuts, mainly almonds, raisins, prunes and peanuts.

Nuts (0802) - mainly almonds. U.S. exports of almonds to Slovakia have been quite stable over the past 5 years averaging about \$400,000 per year with almost 90% of share of all almonds exported to Slovakia.

Raisins (0806) – U.S. raisins entered the Slovak market only a couple years ago and U.S. exports amounted to about \$250,000 in 1998. The U.S. share of imports is about 15%.

Dried fruits (0813) U.S. prunes exported to Slovakia amount to around \$200,000 per year and the U.S. share of all imports is about 10% (of all HTS 0813 commodities). The share of U.S. prunes on Slovak market is more than 30%.

Exports of U.S. peanut products to Slovakia (1201 and 2008) have dried up during the last few years. While in 1994 and 1995 U.S. exports were more than \$500,000 per year, the port value dropped to less than \$200,000 in 1998 and a further decline is expected in 1999. This is mainly due to cheaper imports from China and Czech Republic.

Trade Regulations

Since there is virtually no production of dried fruits and nuts in Slovakia, there are almost no trade barriers to imports. The value added tax (VAT) on dried fruits and nuts is 10% except for value added products such as chocolate raisins, chocolate peanuts, etc. where the VAT is 23%. Automatic import licences are required for peanuts.

Prices

Retail prices vary based on the size and location of the store, distributor, and type of packaging. Discounts for large buyers such as the hypermarket TESCO have tended to drive prices down. Nuts and dried fruits are also sold on the open markets by weight. The price on the open market is about 15-20% lower than at the hypermarket (retail) level. The usual retail margin on dried fruits or nuts is about 25%.
