Report Highlights:

On August 3, 2021, the European Union (EU) extended for an additional five years the anti-dumping and countervailing duties (AD/CVD) levied on imports of U.S. biodiesel since 2008.

THIS REPORT CONTAINS ASSESSMENTS OF COMMODITY AND TRADE ISSUES MADE BY USDA STAFF AND NOT NECESSARILY STATEMENTS OF OFFICIAL U.S. GOVERNMENT POLICY On August 3, 2021, the European Union (EU) extended for an additional five years the AD/CVD levied on imports of U.S. biodiesel since 2008. As a result of the investigation, the EU published <u>Implementing Regulation (EU) 2021/1266</u> which imposes an **anti-dumping duty** rate of up to EUR 198 per ton net on imports of biodiesel from the United States. The product concerned currently falls within the following CN codes of the <u>EU combined</u> nomenclature: CN codes ex 1516 20 98 (TARIC code 1516209829), ex 1518 00 91 (TARIC code 1518009129), ex 1518 00 99 (TARIC code 1518009929), ex 2710 19 43 (TARIC code 2710194329), ex 2710 19 46 (TARIC code 2710194629), ex 2710 19 47 (TARIC code 2710194729), ex 2710 20 11 (TARIC code 2710201129), ex 2710 20 16 (TARIC code 2710201629), ex 3824 99 92 (TARIC code 3824999212), ex 3826 00 10 (TARIC codes 3826001029, 3826001059, 3826001099) and ex 3826 00 90 (TARIC code 3826009019).

The anti-dumping duties are extended to imports of biodiesel consigned from Canada, whether declared as originating in Canada or not, as well as to biodiesel in a blend containing by weight 20 % or less of fatty-acid mono-alkyl esters and/or paraffinic gasoil obtained from synthesis and/or hydro-treatment, of non-fossil origin, originating in the United States. Some exporting producers from Canada (listed in article 2 of 2021/1266) are exempted from the measures imposed by the Regulation.

Additionally, the EU published Implementing Regulation (EU) 2021/1267 which imposes **countervailing duties** of up to EUR 237 per ton net on imports from the United States. The product concerned currently falls within the following CN codes of the EU combined nomenclature: CN codes ex 1516 20 98 (TARIC code 1516209829), ex 1518 00 91 (TARIC code 1518009129), ex 1518 00 99 (TARIC code 1518009929), ex 2710 19 43 (TARIC code 2710194329), ex 2710 19 46 (TARIC code 2710194629), ex 2710 19 47 (TARIC code 2710194729), ex 2710 20 11 (TARIC code 2710201129), ex 2710 20 16 (TARIC code 2710201629), ex 3824 99 92 (TARIC code 3824999212), ex 3826 00 10 (TARIC codes 3826001029, 3826001059, 3826001099) and ex 3826 00 90 (TARIC code 3826009019).

The countervailing duties in force on imports of biodiesel from the United States were extended to cover also imports of the same product consigned from Canada, whether declared as originating in Canada or not, and to imports of biodiesel in a blend containing by weight 20% or less of fatty-acid mono-alkyl esters and/or paraffinic gasoil obtained from synthesis and/or hydro-treatment, of non-fossil origin, originating from the United States. Some exporting producers from Canada (listed in article 2 of 2021/1267) are exempt from the measures imposed by the Regulation
