EU Extends Ban on Portugal's Beef Exports

Report Highlights:

Due continuing high incidence BSE cases in Portugal, the EU will extend the ban on Portugal's beef exports until at least 31 July, 2000. The embargo on live cattle exports remains in effect. 1 USD = 192 Pte.

Executive Summary

As the 31 July deadline for the EU's embargo on Portugal's beef exports is approaching, the EU Commission has decided to extend the ban for at least until 31 July 2000. The EU's proposal is currently going through the final stages of EU clearance procedures, and is expected to be approved by July 19th.

Two main factors led to the extension of the ban: Portugal's classification as a high risk country by international epizootic organization (IEO) standards; and most importantly, continually rising BSE cases. By IEO standards, a country is considered to be high-risk if during a one year period the disease incidence is over 100 cases per million head of adult cattle (i.e. animals more than 24 old). This threshold was clearly surpassed as Portugal's IEO index was 191.8 between June 1998 and May 1999. As for BSE numbers, the national veterinary authorities report that during the first semester of 1999, BSE-positive cases were 57, compared to 44 during the first semester of 1998, and 10 during that of 1997. The GOP opposed the Commission's decision, arguing against the legitimacy of using the IEO index and claiming that BSE was gradually being controlled due to their anti-BSE Program. However, it is expected that in the future the ban will probably be extended again for another couple of years, as it will take Portugal more time to satisfy the EU Commission's risk assessments.

It is hard to predict what, if any, impact the extension of the ban will have on the beef market and the beef sector in general. The public's reaction to the announcement of the original 9-month EU embargo on November 1998 has so far been muted, which enabled per capita beef consumption to continue growing. Seriously affected by the 1996 BSE-shock that took place after the announcement the disease could be transmitted to humans, per capita beef consumption rebounded in 1997 and 1998, with the national cattle producers federation reporting it be at 86% of its 1996 pre-crisis level. In any case, Portugal's beef exports have never been significant.

The extension of the embargo is expected to be formally approved by the 20 EU Commissioners on 9 July and presented to voting by the Standing Veterinary Committee on July 13-14. Failing to achieve qualified majority, the proposal will be voted in the EU Ministers Council meeting on July 19. Following proof that no BSE case was identified in the Azores, the islands have been excluded from the embargo proposal. Other measures to be considered include lifting the ban on exporting fighting bulls, an activity of some interest to Portugal. However, the export regulations in this case are so restrictive that in practical terms the measure is expected to have minimal benefits for the local producers.

Live cattle exports remain subject to a EU ban also established in November 1998 for an 18-month period, which will likely be extended as well. During Jan/March 1999, Portugal has imported 10,595 Mt of beef, mostly from the EU, and exported 46 Mt, mostly into Angola.
