### COMMISSION AWARDS UNDER OPEN MARKET EXPORT TENDERS, EU Grain Management Committee Meeting of December 18, 2003

Under Regulation 1875/03: Offers for 3,600 MT, 2,250 MT granted with a restitution of €148/MT.

Under Regulation 1876/03: Offers for 10,184, 4,060 MT accepted with a restitution of €148.10/MT

Under Regulation 1877/03: Offers for 7,750 MT, 2,500 MT accepted, with a restitution of €287/MT

Under Regulation 1878/03 (Reunion): Offers for 2,500 MT, none accepted.
