### **Report Highlights:**

This report contains summaries of relevant decisions and documents from the Armenia-Belarus-Kazakhstan-Kyrgyzstan-Russia Eurasian Economic Union (EAEU) meetings, published between December 7, 2019, and May 18, 2020, that impact EAEU food and agriculture policy. Key documents included herein are decisions deferring scheduled import tariff increases for agricultural items for Armenia and Kyrgyzstan from 2020 to 2021, allowing temporary duty-free imports into the EAEU of some critical food items and establishing a temporary ban on exports from the EAEU of a number of food products, most notably sunflower seeds and soybeans, as part of the EAEU coronavirus pandemic response.

#### **General Information:**

This report contains summaries of relevant decisions and documents from the Armenia-Belarus-Kazakhstan-Kyrgyzstan-Russia Eurasian Economic Union <sup>1</sup> (EAEU) meetings, published between December 7, 2019, and April 23, 2020, that impact EAEU food and agriculture policy. Key documents included herein are decisions deferring scheduled import tariff increases for agricultural items for Armenia and Kyrgyzstan from 2020 to 2021, allowing temporary duty-free imports into the EAEU of some critical food items and establishing a temporary ban on exports from the EAEU of a number of food products, most notably sunflower seeds and soybeans, as part of the EAEU coronavirus pandemic response.

**Summary:** Russia and Kazakhstan notified the World Trade Organization (WTO) of the draft via G/SPS/N/RUS/173 of January 8, 2020, and G/SPS/N/KAZ/49 of February 17, 2020, respectively. The proposed measure clarifies the term "sample" and adds provisions on the storage and return of samples to the owner. As of the date of this report, the draft has not yet been adopted by the EEC.

2. **Phytosanitary Measures:** On Draft Decision of the Council of the Eurasian Economic Commission "On Amending the List of Quarantine Products (Quarantine Cargo, Quarantine Materials, Quarantine Goods) that are Subject to Quarantine Phytosanitary Control at the Customs Border of the Eurasian Economic Union and in the Customs Territory of the Eurasian Economic Union" – original in Russian <a href="here">here</a>. **Summary:** Russia and Kazakhstan notified the World Trade Organization (WTO) of the draft via <u>G/SPS/N/RUS/174</u> of January 9, 2020, and <u>G/SPS/N/KAZ/50</u> of February 17, 2020, respectively. The proposed measure adds toys containing seeds and (or soil) to the list and excludes feed products not containing organic substances from the list of quarantine products.

**Summary:** Russia and Kazakhstan notified the World Trade Organization (WTO) of the drafts via <u>G/SPS/N/RUS/172</u> of December 17, 2019, and <u>G/SPS/N/KAZ/54</u> of February 24, 2020, respectively. The drafts would lift a number of requirements on imports of bovine semen, sheep and goats and pork meat into the territory of the Eurasian Economic Union. As of the date of this report, the drafts have not yet been adopted by the EEC.

**Summary:** On January 7, 2020, Russia notified the World Trade Organization (WTO) of the draft amendments via <u>G/TBT/N/RUS/93</u>. The draft measure aims to clarify certain provisions of the TR on the production, storage, transportation and processing of fat and oil products, as well as bring it into compliance with the current EAEU labeling requirements. As of the date of this report, the draft has not yet been adopted by the EEC.

Veterinary Requirements: Draft decision "On Amending the Unified Veterinary (Veterinary and Sanitary) Requirements to Goods that are Subject to Veterinary Control (Supervision)" - original in Russian. **Summary:** Russia, Kyrgyzstan, and Kazakhstan notified the World Trade Organization (WTO) of the draft via <u>G/SPS/N/RUS/175</u> of January 9, 2020, <u>G/SPS/N/KGZ/10</u> of February 3, 2020, and <u>G/SPS/N/KAZ/51</u> of February 17, 2020, respectively. The proposed measure removes many

(but not all) exceptions from the uniform EAEU veterinary requirements currently enjoyed by Belarus regarding the use of veterinary measures for low risk products. **Summary:** Russia and Kazakhstan notified the World Trade Organization (WTO) of the drafts via G/SPS/N/RUS/177 of February 3, 2020, and G/SPS/N/KAZ/53 of February 24, 2020, respectively. The proposed measures would introduce amendments to Chapter 18 of the Unified EAEU veterinary requirements and form No. 18 of a unified EAEU veterinary certificate, which both currently cover imported honeybees, bumblebees and cocoons of alfalfa leafcutter bees, to include import requirements for crickets, entomophagous insects and other insects. **Summary:** Russia notified the World Trade Organization (WTO) of the drafts via G/SPS/N/RUS/180 of February 21, 2020. The notified documents would introduce a new Chapter 47 with the veterinary requirements for gastropod mollusks imported into the EAEU and a new form No. 48 of a unified EAEU veterinary certificate for imported gastropod mollusks. Summary: Kazakhstan and Kyrgyzstan notified the World Trade Organization (WTO) of the draft via G/SPS/N/KGZ/12 of March 18, 2020, and G/SPS/N/KAZ/68 of April 23, 2020, respectively. According to the notification, the draft provides for supplementing decision of the Customs Union Commission No. 318 of June 18, 2010 "On Ensuring Plant Quarantine in the Eurasian Economic Union" with provisions allowing designated officials of the authorized plant quarantine bodies of the EAEU Member States to recognize phytosanitary certificates as not confirming the necessary phytosanitary condition of imported regulated products. The draft also grants authority to the authorized body to return wood packaging materials if a special marking sign of an international standard confirming that the wood packaging materials have been treated by heating throughout the thickness of wood or fumigation is missing, or wood packaging materials do not comply with the Unified EAEU Quarantine Phytosanitary Requirements. ## MEETING OF THE EURASIAN ECONOMIC COMMISSION COUNCIL December 19, 2019

Publication Date: January 23, 2020

**EEC Council Decision No. 118**. On Amending Technical Regulation of the Customs Union "On Safety of Milk and Dairy Products" (TR CU 033/2013) - original in Russian

**Summary:** The decision grants an exemption to the Republic of Kazakhstan from the aerobic mesophilic and facultative anaerobes count standard of the CU TR on Milk and Dairy Products for raw milk through 2024. Dairy products produced from such exempted milk should be

consumed in the Republic of Kazakhstan and should not be exported to the other EAEU Member States. The document also specifies that Kazakhstan should upgrade its dairy industry by January 1, 2025 in order to ensure full compliance of its products with the requirements CU TR on Milk and Dairy Products.

EEC Council Order No. 46. On Draft Protocol Amending the Protocol on the Terms and Transitional Provisions for the Application by the Kyrgyz Republic of the Treaty on the Eurasian Economic Union of May 29, 2014, Certain International Agreements in the Legislation of the Eurasian Economic Union, and Acts of the Eurasian Economic Union Bodies in Connection with Accession of the Kyrgyz Republic to the Treaty on the Eurasian Economic Union of May 29, 2014, signed on May 8, 2015, and the Protocol Amending the Treaty on Accession of the Republic of Armenia to Treaty on the Eurasian Economic Union of May 29, 2014, signed on October 10, 2014 - original in Russian

**Summary:** The order amended schedules of temporary EAEU import tariff exemptions for Armenia and Kyrgyzstan. In particular, both Armenia and Kyrgyzstan were allowed to defer their scheduled tariff increases for agricultural items from 2020 to 2021. The document is pending ratification by the EAEU Member States and is in effect provisionally as of the day of its publication, April 14, 2020.

# MEETING OF THE EURASIAN ECONOMIC COMMISSION COUNCIL January 30, 2020

Publication Date: February 21, 2020

**EEC Council Decision No. 10**. On the Unified Methods for Determining Varietal Characteristics of Agricultural Plants in the Framework of the Eurasian Economic Union - original in Russian.

**Summary:** The decision approves methods of field evaluation, control and approval of seeds as required by the Agreement on the Circulation of Seeds of Agricultural Plants within the Framework of the Eurasian Economic Union signed in November 2017. The document establishes uniform requirements for evaluation of varietal qualities of seeds in the EAEU Member States, identification of seeds of agricultural plants, assessment of varietal purity of batches of seeds at various stages of seed production. The document is used during soil control and varietal identification of such crops as grains, legumes, oilseeds, vegetables, melons, medicinal crops and potatoes to determine their suitability for seed purposes.

**EEC Council Decision No. 16**. On Establishing the Rate of Import Tariff of the Unified Customs Tariff of the Eurasian Economic Union in Respect of Surimi of Certain Kinds of Fish and Amending the List of Goods, which in Accordance with the Commitments of the Republic of Kazakhstan as Part of its Accession to the World Trade Organization shall be Subject to Import Customs Duty Rates that are Lower than the Rates of the Unified Customs Tariff of the Eurasian Economic Union, and the Rates of Such Duties - original in Russian

**Summary:** The decision temporarily reduced the import tariff on frozen surimi (EAEU HS code 0304 95 100 0) from 5 percent to zero from the date of its entry into force (March 26, 2020) through April 30, 2023. This is not the first tariff reduction for this item as temporary zero tariff has been intermittently set for this item since late 2016.

## MEETING OF THE EURASIAN ECONOMIC COMMISSION COUNCIL April 3, 2020

**EEC Council Decision No. 33**. On Amending Some Decisions of the Customs Union Commission and on Approving the List of Goods of Critical Imports - original in Russian.

**Summary:** The decision introduced a temporary exemption from import duties for critical food products, such as potatoes, onions, garlic, cabbages, rice, rye, buckwheat, etc. The measure, which came into effect on April 18, 2020, applies to products imported as of April 1, 2020, and will be in effect through June 30, 2020. **EEC Collegium Decision No. 23**. On Establishing Rates of Import Tariff of the Unified Customs Tariff of the Eurasian Economic Union in Respect Certain Types of Mollusks and Krill Meat - original in Russian

**Summary:** The decision temporarily reduces the EAEU import tariff on mollusks and krill meat items under the EAEU HS codes 0307 43 380 0, 0307 43 900 0, 0307 52 900 0, 1605 40 000 1 and 1605 53 900 0, to zero percent from March 26, 2020, through March 31, 2023. Regular EAEU import tariff rates for these items range from 5 to 8 percent. This is a second temporary zero import tariff period for all of the items above following the first reduction that was in effect between November 2017 and December 2019.

**EEC Collegium Recommendation No. 4**. On Methodological Guidelines for Establishment and Justification of Hygienic Standards for the Content of Chemical Impurities and Biological Agents in Food by the Criteria of Risk to Human Health - original in Russian

**Summary:** The document recommends that EAEU Member States use the stated Guidelines that are published on the EAEU website (<u>in Russian</u>) when developing new MRLs for chemical impurities and biological agents in food.

**Summary:** The decision was taken in response to a request from the Republic of Belarus for the stated approval following the introduction of the state regulation of prices for white granulated sugar by Belarus as of January 1, 2020. The EAEU granted an extension of such state regulation of prices for white granulated sugar in Belarus through December 31, 2020.

**EEC Collegium Decision No. 42**. On Amending the List of Goods that are of Critical Importance for the Domestic Market of the Eurasian Economic Union, and for which in Exceptional Cases Temporary Export Bans or Quantitative Restrictions may be Introduced - original in Russian

**Summary:** The decision is part of the EAEU coronavirus pandemic response and it adds set onion, onions, garlic, turnip and prepared food products from buckwheat to the respective list of products, for which the EAEU may impose export bans in the future.

**EEC Collegium Decision No. 43**. On Amending Decision of the Eurasian Economic Commission Collegium No. 30 of April 21, 2015 "On Non-Tariff Regulation" - original in Russian

**Summary:** The decision introduced a ban on exports from the EAEU of a number of food products, most notably sunflower seeds and soybeans. The export ban came into effect on April 12, 2020, and will last through June 30, 2020. The measure was also introduced as part of the EAEU coronavirus pandemic response. **EEC Collegium Decision No. 57**. On Amending Section 1.11 of the List of Goods that are Banned for Import into the Customs Territory of the Eurasian Economic Union and (or) Banned for Export from the Customs Territory of the Eurasian Economic Union - original in Russian

**Summary:** The decision excludes 20,000 tons of Kazakhstani soybeans (EAEU HS code 1201) from the above ban on exports from the EAEU and adds another note to the list of banned food products specifying exemptions from the ban.

**EEC Collegium Decision No. 58**. On Approval to Extend the Period of the State Regulation of Prices for Buckwheat - original in Russian

**Summary:** The decision was taken in response to a request from the Republic of Belarus for the stated approval following the introduction of the state regulation of prices for buckwheat by Belarus as of November 1, 2019, and expiration of the first such EAEU approval on April 28, 2020. The EAEU granted an extension of such state regulation of prices for buckwheat in Belarus through September 30, 2020.
