Report Highlights:

Brazil requires imports and exports of animal-origin products be accompanied by certificate with animal health attestations and/or public health attestations. Import requirements are defined by the Ministry of Agriculture and Livestock (MAPA) and a certificate model must be bilaterally negotiated before trade starts. This report identifies the certifies and import requirements for agricultural products destined for human and animal consumption, as well as animal importation. This report supplements and should be considered in conjunction with the FAIRS Annual Country Report for Brazil.

EXECUTIVE SUMMARY:

The FAIRS Export Certificate Report contains general information on Brazil's major export certificates and other requirements established by the local government authorities for the importation of U.S. food and agricultural products into Brazil. Brazil requires that imports and exports of animal-origin products be accompanied by certificate with animal health attestations and/or public health attestations. Import requirements are defined by the Ministry of Agriculture and Livestock (MAPA) and a certificate model has to be bilaterally negotiated before trade starts.

This report includes information on different certificates by product, as well as attestations and other requirements on products that have already been negotiated bilaterally with MAPA. The list presented in the report should not be considered final, as there are ongoing negotiations in place. When accessing this report throughout the year, please consider consulting the USDA offices in Brazil if the product you are looking for is not listed on this report. Additionally, U.S. exporters are encouraged to periodically access FAS Global Agricultural Information Network (GAIN) and seek for reports from the Agricultural Affairs and Agricultural Trade Offices in Brazil for possible changes in regulations and standards throughout the year.

The certificate must follow a special format defined by MAPA. The veterinary authority from APHIS must sign these certificates.
- 60. <u>Veterinary Health Certificate for Export of Rodent Semen for Research for Laboratory use</u> <u>from the United States of America to Brazil</u>: MAPA requires specific animal health

attestations – please reference the certificate provided in this report. The certificate must follow a special format defined by MAPA. The veterinary authority from APHIS must sign these certificates.

- 61. <u>Veterinary Health Certificate for Export of Dogs and Cats from the United States to Brazil</u>: Requirements and specifications are accessible on the <u>APHIS Pet Travel</u> website.
- 62. International Health Certificate for Export of Erinaceids (Hedgehog) from the United States to Brazil: MAPA requires specific animal health attestations please reference the certificate provided in this report. The certificate must follow a special format defined by MAPA. The veterinary authority from APHIS must sign these certificates.
- 63. <u>Health Certificate for the Exportation of Pet Rabbits from the United States to Brazil:</u> MAPA requires specific animal health attestations – please reference the certificate provided in this report. The certificate must follow a special format defined by MAPA. The veterinary authority from APHIS must sign these certificates.
- 64. <u>International Zoosanitary Certificate to Export from United States to Brazil Rodents as Pet</u> <u>Animals or With Commercial Purpose:</u> MAPA requires specific animal health attestations – please reference the certificate provided in this report. The certificate must follow a special format defined by MAPA. The veterinary authority from APHIS must sign these certificates.
- 65. <u>Health Certificate for the Export of Ornamental Pet Birds from the United States to Brazil</u>: MAPA requires specific animal health attestations – please reference the certificate provided in this report. The certificate must follow a special format defined by MAPA. The veterinary authority from APHIS must sign these certificates.
- 66. <u>Phytosanitary Certificate</u>: MAPA requires specific public health attestations for human consumption and an attestation that the plants are free of pests and diseases. The certificate's attestations will vary by product. For example, in the case of strawberries, the certificate must have an attestation that they are free of mites. APHIS issues certificates for several types of plant products. Requirements and specifications are accessible on the <u>APHIS</u> <u>FAVIR</u> website.

SECTION III. GOVERNMENT CERTIFICATE LEGAL ENTRY REQUIREMENTS

- <u>Certificate for Export of Beef, Beef Products, and Offal to Brazil</u>: Prior to product shipment, the importer must request from MAPA an import permit (abbreviated as "LI" in Portuguese); importers must be registered with the Ministry of Economy's Integrated Foreign Trade System (*Sistema Integrado de Comércio Exterior - SISCOMEX*) in order to request an LI. Import permits are valid for a maximum of 30 calendar days. The original certificate must accompany the product at the time of entry.
- 2. <u>Sanitary Certificate for Milk and Milk Products Exported to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request a LI, which is valid for a maximum of 30 calendar days. The original certificate must accompany the product at the time of entry.
- 3. <u>Health Certificate for Fish and Fish Products from Wild Fisheries (except shrimp and live animals</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI, which is valid for a maximum of 30 calendar days. The original certificate must accompany the product at the time of entry.
- 4. <u>Health Certificate for Lobster and Lobster Products from Wild Fisheries</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI, which is valid for a maximum of 30 calendar days. The original certificate must accompany the product at the time of entry.
- 5. <u>Good Manufacturing Practices Certificate for Animal-Origin Feed Products</u>: MAPA requires a GMP certificate, which is used to obtain plant approval to export animal-origin feed products to Brazil. This certificate is not required to accompany the product. GMP certificates for animal-origin products are issued by APHIS, which will issue a separate health certificate for each feed category or animal supplement. The certificate must accompany the imported goods. MAPA does not accept third-party GMP certificates, but they do accept GMP certificates issued by U.S. states. For example, a certificate issued by the Wisconsin Department of Agriculture would be acceptable to the Brazilian authorities.
- 6. <u>Certification Requirements for the Export of Feeds Intended for Aquatic Species to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- Certification Requirements for Bovine Serum or Plasma for Animal Feeding: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-

4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.

- 8. <u>Animal Health Requirements of Brazil for Dairy Products Destined for Animal Feeding from the United States</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 9. Certification Statements for Export of Egg Products Intended for Animal Feeding to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 10. Extruded and Pelletized Pet Foods for Dogs, Cats, Reptiles, and Ferrets (Mustelidae) to Brazil from the United States: The export of extruded and pelletized pet foods to Brazil requires that the exporting company be registered with MAPA. Product registrations are required and valid for 10 years. Product registration requires evidence that the product and the manufacturing company are authorized to produce the product in the United States.
- 11. <u>Certification Requirements for the Export of Feather Meals for Animal Feeding to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 12. International Veterinary Certificate for the Export of Fish Meal and/or Fish Oil, Including Derivatives, for Animal Feeding: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 13. <u>Import Requirement Porcine Meat-and-Bone Meals and/or Porcine Digests Intended for</u> <u>Animal Feeding to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required

bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.

- 14. Poultry Meat-and-Bone Meals and/or Poultry Digests Intended for Animal Feeding to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 15. <u>Moist Pet Foods for Dogs, Cats, Reptiles and Ferrets (Mustelidae) Exported from the United</u> <u>States to Brazil</u>: The export of extruded and pelletized pet foods to Brazil requires that the exporting company be registered with MAPA. Product registrations are required and valid for 10 years. Product registration requires evidence that the product and the manufacturing company are authorized to produce the product in the United States.
- 16. International Veterinary Certificate for the Export of Spray Dried Porcine Blood Products for Animal Feeding: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services. The certificate is only valid for 30 days after the date of signature.
- 17. <u>Artemia and Rotifer Cysts</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services. The certificate is only valid for 30 days after the date of signature.
- 18. International Veterinary Certificate for the Export of Processed Bee Products to Brazil Intended for Uses Other Than Human and Animal Consumption: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as

necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services. The certificate is only valid for 30 days after the date of signature.

- 19. Defibrinated Ovine Blood Exported to Brazil for Laboratory Use: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 20. <u>Cultivated Bovine Fetal Fibroblasts for Scientific Research Purposes</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 21. <u>International Veterinary Certificate for the Export of Fresh Salted Bovine, Ovine, Caprine and Porcine Skins/Hides from the United States to Brazil</u>: Prior to product shipment, the importer must request an LI request from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for hides. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry.
- 22. <u>Fetal Bovine Serum</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 23. Zoosanitary Certificate for Exports of Gelatin and/or Collagen of Bovine and Porcine Origin from United States to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services. The certificate is only valid for 30 days after the date of signature.

- 24. <u>Hunting Trophies</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 25. <u>Certification Requirements for the Export of Scoured Wool to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. The required bilingual (English/Portuguese) certification statements should be made in the "Additional Declaration" section of VS Form 16-4, Export Certificate for Animal Products, and the continuation page(s) of VS Form 16-4A, as necessary. A notarized affidavit from the manufacturer is required to support these statements on the export certificate issued by APHIS Veterinary Services.
- 26. <u>Veterinary Drugs and Media for Laboratory Use Containing Animal-Origin Ingredients</u>: Veterinary drugs that are not licensed by the APHIS Center for Veterinary Biologics and media for laboratory use containing animal-origin ingredients exported to Brazil must be accompanied by an animal health certificate in English and Portuguese issued by the Official Veterinary Service. Prior to product shipment, the importer must request an LI from MAPA. The original certificate must accompany the product at the time of entry.
- 27. <u>International Veterinary Certificate for Export of Equine Embryos from the United States to</u> <u>Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the animal at the time of entry.
- 28. <u>International Veterinary Certificate Model for the Permanent Export of Horses to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the animal at the time of entry.
- 29. <u>International Health Certificate for the Return from Brazil of Equines Temporarily Exported</u> to United States of American that Attended Horse Assemblage Events not for Reproduction: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for the temporary export of live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the animal at the time of entry.
- 30. International Animal Health Certificate for Export of Equine Frozen Semen from the United States to Brazil: Prior to product shipment, the importer must request an LI request from

MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for equine semen. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.

- 31. International Zoosanitary Certificate for the Temporary Export of Equidae From United States to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for the temporary export of live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the animal at the time of entry.
- 32. <u>International Veterinary Certificate for the Export of Live Cattle for Breeding from the United States to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live cattle. Forms must be signed and stamped by an APHIS-accredited veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the animal at the time of entry.
- 33. International Health Certificate for the Export of Bovine Embryos Collected *in Vivo* and/or Produced *in Vitro* from United States to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for bovine embryos. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.
- 34. <u>Health Certificate for Exportation of Bovine Embryos to Brazil from the United States of America</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the animal at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.
- 35. <u>Veterinary Health Certificate for Export of Frozen Bovine and Bison Semen from the United</u> <u>States to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for bovine semen. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.

- 36. <u>Addendum to the Health Certificate for U.S. Bovine Semen to Brazil for Semen Which Was</u> <u>Previously Imported to the United States</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for bovine semen. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.
- 37. International Health Certificate to Accompany Exports of Goat and Sheep from the United States to Brazil for Breeding or Feeding: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the animal at the time of entry.
- 38. Goat Embryos: Under negotiation.
- 39. <u>Animal Health Certificate for Exportation of Caprine Semen from the United States to</u> <u>Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for caprine semen. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.
- 40. <u>International Animal Health Certificate for United States Frozen Ovine Semen Exported to</u> <u>Brazil</u>: Prior to product shipment, the importer must request an LI request from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for ovine semen. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.
- 41. <u>International Animal Health Certificate to Accompany Exports of Ovine Embryos Collected</u> <u>in Vivo Exported from United States to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the animal at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.

- 42. <u>Veterinary Health Certificate for Export of Swine for Breeding from the United States of</u> <u>America to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live swine. Forms must be signed and stamped by an accredited APHIS veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the animal at the time of entry.
- 43. <u>Model International Certificate (CVI) for the Export of Frozen Pork Semen from Unites</u> <u>States to Brazil</u>: Prior to product shipment, the importer must request an LI request from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for pork semen. Forms must be signed and stamped by an APHISaccredited veterinarian. The original certificate must accompany the product at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.
- 44. <u>International Veterinary Certificate for the Importation of Hatching Eggs of Domestic Birds</u> <u>and Day-Old Poultry</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for hatching eggs of domestic birds and day-old poultry. Forms must be signed and stamped by an APHIS-accredited veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the shipment at the time of entry.
- 45. <u>Animal Health Certificate for Exportation of Hatching SPF (Specific-Pathogen-Free) Eggs</u> from the United States to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for SPF eggs. Forms must be signed and stamped by an APHIS-accredited veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the shipment at the time of entry.
- 46. <u>International Health Certificate for the Export of Captive Birds (Wild or Ornamental) from</u> <u>United States to Brazil</u>: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues these health certificates. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the shipment at the time of entry.
- 47. <u>Health Certificate for the Export of Live Finfish, Mollusks, and Crustaceans (and their Gametes) and Addendum to the VS Form 17-141 for Export of the *Penaeidae* Family from United States to Brazil: Prior to product shipment, the importer must request an LI from MAPA. The animals were examined within 5 days before shipment and showed no cutaneous lesions and no clinical signs of disease, or suspicion of disease and were considered fit for transport. The original certificate must accompany the product at the time of entry.</u>

- 48. <u>Animal Health Import Requirements for Aquatic Animals for Ornamental Purposes Not</u> <u>Intended for Commercial Reproduction</u>: Animals imported for this purpose must remain into closed containers, e.g. aquariums or closed ornamental ponds. Prior to product shipment, the importer must request an LI request from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for ornamental fish.
- 49. <u>Animal Health Certificate Model to Accompany the Exportation of Embryonated Eggs of</u> <u>Rainbow Trout from the United States to Brazil for Breeding Purposes</u>: The aquatic animals to be exported must be shipped under conditions, including water quality, that do not alter their health status. The animals must be: 1) packaged in a way to not change their health condition; and 2) placed in new containers or ones that were previously cleaned and disinfected with officially approved products. Prior to product shipment, the importer must request an LI request from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for rainbow trout eggs. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry.
- 50. <u>Veterinary Health Certificate for Export of Tilapia from the United States to Brazil:</u> Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for Nile Tilapia Fingerings. Forms must be signed and stamped by an APHIS-accredited veterinarian.
- 51. Veterinary Health Certificate for Export of Antelopes from the United States of America to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues these health certificates. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the shipment at the time of entry.
- 52. <u>International Animal Health Certificate for Export of Dog Semen from the United States of America to Brazil</u>: Prior to product shipment, the importer must request an LI request from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for dog semen. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.
- 53. <u>International Zoosanitary Certificate for the Export to Brazil of Carnivorous Animals to Brazil for Any Purposes:</u> Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues these health certificates. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the shipment at the time of entry.
- 54. International Zoosanitary Certificate of Origins for Marsupials as Pets or Commercial <u>Purposes:</u> Prior to product shipment, the importer must request an LI from MAPA.

Importers must be registered with SISCOMEX to request an LI. APHIS issues these health certificates. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the shipment at the time of entry.

- 55. International Veterinary Certificate (CVI) Model for the Permanent Export of Zebras to <u>Brazil:</u> Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues these health certificates. Forms must be signed and stamped by an APHIS-accredited veterinarian. The health certificate is valid for 10 days prior to embarkation. The original certificate must accompany the shipment at the time of entry.
- 56. <u>International Zoosanitary Certificate for the Export to Brazil of Giraffes:</u> Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues these health certificates. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the shipment at the time of entry.
- 57. <u>Health Certificate for Export of Primates from the United States to Brazil:</u> Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues these health certificates. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the shipment at the time of entry.
- 58. <u>International Zoosanitaary Certificate of Origin for Live Laboratory Animals:</u> Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues these health certificates. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the shipment at the time of entry.
- 59. <u>Veterinary Health Certificate for Export of Rodent Embryos for Research or Laboratory Use</u> from the United States of America to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the animal at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.
- 60. <u>Veterinary Health Certificate for Export of Rodent Semen for Research for Laboratory use</u> from the United States of America to Brazil: Prior to product shipment, the importer must request an LI from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for live horses. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the animal at the time of entry. The certificate cannot be applied to multiple containers. Each container must have only one species. If the importer has purchased different species, they must be shipped in separate containers.

- 61. <u>Veterinary Health Certificate for Export of Dogs and Cats from the United States to Brazil</u>: APHIS issues health certificates for pet dogs and cats. Forms must be signed and stamped by an APHIS-accredited veterinarian. This International Veterinary Certificate is valid for 60 days from the date of issuance. The original certificate must accompany the animal at the time of entry.
- 62. International Health Certificate for Export of Erinaceids (Hedgehog) from the United States to Brazil: APHIS issues health certificates for pet dogs and cats. Forms must be signed and stamped by an APHIS-accredited veterinarian. This International Veterinary Certificate is valid for 60 days from the date of issuance. The original certificate must accompany the animal at the time of entry.
- 63. <u>Health Certificate for the Exportation of Pet Rabbits from the United States to Brazil:</u> APHIS issues health certificates for pet dogs and cats. Forms must be signed and stamped by an APHIS-accredited veterinarian. This International Veterinary Certificate is valid for 60 days from the date of issuance. The original certificate must accompany the animal at the time of entry.
- 64. <u>International Zoosanitary Certificate to Export from United States to Brazil Rodents as Pet</u> <u>Animals or With Commercial Purpose:</u> APHIS issues health certificates for pet dogs and cats. Forms must be signed and stamped by an APHIS-accredited veterinarian. This International Veterinary Certificate is valid for 60 days from the date of issuance. The original certificate must accompany the animal at the time of entry.
- 65. <u>Health Certificate for the Export of Ornamental Pet Birds from the United States to Brazil</u>: Prior to product shipment, the importer must request an LI request from MAPA. Importers must be registered with SISCOMEX to request an LI. APHIS issues health certificates for pet birds. The birds must have been inspected by an official or accredited veterinarian within 7 days prior to shipment and be found free of clinical signs of infectious and contagious diseases and external parasites. Forms must be signed and stamped by an APHIS-accredited veterinarian. The original certificate must accompany the product at the time of entry.
- 66. <u>Phytosanitary Certificate</u>: APHIS issues phytosanitary certificates, which must be signed and stamped by an APHIS-accredited official. These certificates are usually valid for 90 days and are issued for a single shipment. Certificate must be issued in accordance with protocol requirements.

SECTION IV. OTHER CERTIFICATION/ACCREDITATION REQUIREMENTS TO ENSURE MARKET ENTRY

4.A. Equivalence System for animal-origin products

According to the equivalence system established with Brazil, the United States can only export to Brazil the following animal-origin products:

4.A.1. Meat

Eligible Products

- 1. Beef, beef products, and beef offals sourced from cattle slaughtered and processed on or after July 27, 2016 except as noted below in B. Ineligible Product and the Eligible Establishment List for Brazil.
- 2. Pork casings.
- 3. Lamb casings imported from New Zealand that have not undergone processing or repackaging in the U.S.
- 4. Airline Meals U.S. meat intended for use in meals on airlines for the consumption of the crew and passengers on board international flights may be exported from any U.S. inspected facility.
- 5. Protein free tallow.
- 6. Edible products for pharmaceutical or other industrial purposes.

Meat Plants Eligible for Export:

A. Establishment Registration

- U.S. establishments wishing to export to Brazil are required to submit FSIS Form 9080-3: *Establishment Application for Export* through the Public Health Information System (PHIS). Please refer to <u>FSIS Directive 13,000.5</u>, *Public Health Information System Export Certification*, for more information and instructions on the FSIS web site at: <u>https://www.fsis.usda.gov/sites/default/files/media_file/2021-02/9080-3-Application-Submission.pdf</u>.
- Inspection Program Personnel (IPP) are to be aware that export applicants that do not have access to or use PHIS are to send a fully completed paper copy of FSIS Form 9080-3 to the FSIS Proxy, using one of the three options listed below, for entry into PHIS on the applicant's behalf. FSIS Proxy information is located on the <u>FSIS Export</u> <u>Library</u> page.

- B. Eligible Establishment List for Brazil
 - FSIS will certify these establishments to the Government of Brazil when the Office of International Coordination approves the FSIS Form 9080-3. Product cannot be shipped until confirmation of both establishment and label registration are received from the Government of Brazil. When FSIS receives notification from the Government of Brazil that the establishment is registered with MAPA/DIPOA, FSIS will update the <u>Eligible</u> <u>Establishment List for Brazil</u>.

For more information on Plant Registration and Updated Procedures for Meat and Meat Products, consult <u>GAIN Report BR2022-0024</u>.

Per FSIS export library the following products are ineligible for export to Brazil:

- 1. Beef, beef products, and offals that have undergone radiation treatment.
- 2. Fresh/frozen poultry and poultry products.
- 3. Fresh/frozen and further processed pork and pork products.

Documentation Requirements - Certification:

- 1. **Beef, beef products, and beef offals -** Obtain FSIS Form 9060-5, Export Certificate of Wholesomeness and FSIS Letterhead Certificate for the Export of Beef, Beef Products, and Beef Offals to Brazil (as linked on Section I of this report).
- Glands for Pharmaceutical Use Edible product - Obtain FSIS Form 9060-5. Do not check the box certifying "wholesomeness". Type the following statement in the remarks section "FOR PHARMACEUTICAL USE ONLY".
- 3. **Pork Casings produced domestically** Obtain FSIS Form 9060-7 (08/26/2011), Export Certificate for Animal Casings. In addition a bilingual <u>FSIS Letterhead Certificate is required</u>.

Note: U.S. origin salted hog casings that were sent to China for selection can be certified for export to Brazil. Please note that the Ministry of Agriculture and Livestock has recently requested a new certificate to accompany the exports of casings to Brazil. This is still under negotiation, so Post advises exporters to ship at their risk and suggest coordinating with importers in Brazil.

4. Lamb casings imported from New Zealand that have not undergone processing or repackaging in the U.S. - Obtain FSIS Form 9060-18 (08/25/2011), Animal Casings Export Certificate for Countries Requiring Ante-mortem, Post-mortem, and Sound and Clean Statement.

Note: The exporter is responsible for ensuring that any certification issued by New Zealand that is required for entry into Brazil accompanies the shipment. Please note that the Ministry of Agriculture and Livestock has recently requested a new certificate to accompany the exports of casings to Brazil. This is still under negotiation, so Post advises exporters to ship at their risk and suggest coordinating with importers in Brazil.

5. Airline Meals - Obtain FSIS Form 9060-5. Type the following statement in the "Remarks" section:

"This product is intended for exclusive use for airline or ship meals."

Notes for completing FSIS Form 9060-5:

- a. Certificates should never be stamped with the export stamp or embossed with a stamp.
- b. A product lot number must be provided on the FSIS Form 9060-5 in block 15 for each product listed in block 10.
- c. A packing date or packing date range must be provided in the FSIS Form 9060-5 Remarks block corresponding to each product listed in block 10.
- d. The Establishment number on the product provided on FSIS Form 9060-5 block 16 must be the same as it appears on the <u>Eligible Establishment List for Brazil</u> as this is how the establishment number was registered with Brazil following the process noted in the Establishments Eligible to Export tab.

Note for completing the FSIS Letterhead Certificate for the Export of Beef, Beef Products, and Beef Offals to Brazil.

a. The shipping information table below the FSIS certifying official's signature is to be completed by the applicant or shipping company and is not required to be verified by FSIS or to be completed prior to signing the letterhead certificate by the FSIS certifying official.

The United States can export genetic material to Brazil and other products that contain poultry, as long as it is not for human consumption. Currently, there is no equivalence between the inspection procedures between MAPA and FSIS.

MAPA has concluded an evaluation on regionalization on the issue of Newcastle Disease and Avian Influenza in the United States. If there are outbreaks of these diseases in United States territories, as it happened in the past, exports will continue with material coming from unaffected areas.

Dairy Plants Eligible to Export:

Plant Approval/Registration: Establishments wishing to export to Brazil are required to submit a "Letter of Request for Approval" to the AMS office at dairyexportsquestions@usda.gov, with a copy to USDA FAS Brasília at agbrasilia@usda.gov, to be forwarded by AMS for registration in the Brazilian Approved list.

4.A.3. Fishery

- 1. Fresh and frozen fish;
- 2. Roes and seasoned capelin roes;
- 3. Frozen crustaceous; and
- 4. Lobsters and lobster products

Live Shrimp (*Penaeidae* family) – please follow APHIS' guidance for export of this product. Reference: From the list above, Certificate item 45 "Health Certificate for the Export of Live Finfish, Mollusks, and Crustaceans (and their Gametes)" and "Addendum to the VS Form 17-141 for Export of the *Penaeidae* Family from United States to Brazil".

<u>Certification Requirements:</u>

In January 2010, the Brazilian Ministry, The Department of Fisheries and Aquaculture Control published aquatic health regulations on the fishery products into Brazil. These regulations are within the scope of their authority under OIE and WTO guidelines and are currently in effect. Brazil requires importers in Brazil to obtain import permits prior to bringing seafood products into Brazil. U.S. exporters are required to be USDC NOAA Seafood Inspection Program Approved Establishments

On April 24, 2020, the Brazilian Ministry published Circular Letter#81/2020/DHC/CGI /DIPOA /SDA/ MAPA. This regulation provides for U.S. exports of lobster and lobster product certification using the *Health Certificate For The Import Of Lobster And Lobster Products From Wild Fisheries*. Brazil requires importers in Brazil to obtain import permits prior to bringing seafood products into Brazil. US exporters are required to be USDC NOAA Seafood Inspection Program Approved Establishments.

Impacts on US competent authority and exporters:

The USDC NOAA Fisheries Seafood Inspection Program (SIP) is the competent US authority for aquatic health certification for wild-harvested seafood exports intended for human consumption, as per MOU between NOAA Fisheries and USDA/APHIS.

For fishery products destined for Brazil, NOAA SIP has agreed to:

- Forward "Letters of Request for Approval" from US exporters to DIPOA
- Approve processing facilities under the USDC SIP Approved facilities program prior to export certification
- Certify the product and species being exported
- Verify that the exporter is on the Brazilian Approved List (Ministério da Agricultura, Pecuária e Abastecimento – MAPA, Secretaria de Defesa Agropecuária – SDA, Departamento de Inspeção de Produtos de Origem Animal – DIPOA, Serviço de Inspeção Federal – SIF)
- Ensure all shipments must be lot inspected or shipped under Quality Management System
- Issue SIP Export Health certificates for all shipments. (English/Portuguese certificate to be Approved) All inspected products must have the SIP Export Health certification for Brazil prior to shipment.

U.S. Exporters will be required to follow the guidelines listed below for the exportation of fishery products to Brazil.

• Forward a "Letter of Request for Approval" to the regional SIP office, to be forwarded by the SIP to gain placement on the Brazilian Approved list. Regional SIP will review and

verify the letters then forward to SIP HQ for final approval and forwarding to U.S. Embassy Brazil.

- U.S. Processing facility must be under the USDC SIP Approved facilities program prior to export.
- After Facility Registration is approved, the US facility must identify a Brazilian importer and complete a label registration process.
- All inspected product must have the SIP Export Health certification for Brazil prior to shipment.
- U.S. export shipments are required to present a sworn translation of the USDC SIP Official Health certificate information upon import. Third party Brazilian services are available and accepted for this documentation.

These requirements are the procedural points as agreed to by NOAA Fisheries through the U.S. Embassy/USDA for Brazil during March 2012 meetings.

Other Information:

Tolerances and Guidelines

Total Mercury:

- 0.5 ppm for non-carnivore fish
- 1.0 ppm for carnivore fish.

The Brazilian legislation on sanitary inspection of animal products, RIISPOA, since 1952 through Decree No. 30.691, considers as improper for human consumption fish that contains massive muscle infestation by parasites, which may or may not harm the health of the consumer. RIISPOA was updated through Decree 9.013 / 2017 dated March 29, 2017, duly informed to the WTO, which provides provisions on clearer fish parasites and in agreement with the current scientific literature.

This Decree provides the following requirements on official control and understanding by the establishments:

Article 209 establishes the control of parasites as one of the official controls to be carried out by the sanitary authority.

Article 212 establishes the obligation of visual verification of injuries attributable to diseases or infections, as well as the presence of parasites through monitoring performed by qualified personnel of the establishment.

Art. 499 It considers improper for human consumption the fish or products of fish that presents massive muscular infection by parasites.

US exporters to Brazil must

- implement the Codex Code of Practice for Fish and Fishery Products
- apply the Codex Alimentarius Standard 36-1981 for quick frozen finfish
- apply Codex Standard 190-1995-Rev 2011-2013-2014 Quick Frozen Fish Fillets

Fishery Plants Eligible to Export:

The U.S. Department of Commerce Seafood Inspection Program (SIP) will issue certificates to U.S. facilities that have applied to be part of NOAA's Seafood Inspection Program. For more information, please see:

Plant Approval/Registration: All fish-processing plants must send a formal registration request to NOAA, which will contact FAS/OAA to request that the plant be included in Brazil's official list. Contact the local NOAA SIP office for further inquiries.

4.B. Radiation

In Brazil, irradiated products are governed by the <u>Decree 72718/1973</u>, <u>ANVISA Resolution 21/2001</u>, and <u>MAPA Normative Instruction 09/2011</u>. Brazil follows the recommendations of the International Atomic Energy Agency and uses security patterns established by Codex, WHO, and FAO - to include recommendations on the sources of radiation authorized in Brazil. If requested, companies need to provide records of phytosanitary treatment with information on the origin, purpose, dose, disease targeted, identification of lot and product labelling information. The legislation requires the use of the sentence "FOOD TREATED BY RADIATION PROCESS".

Furthermore, radiation is accepted as phytosanitary treatment for quarantine purposes for the international transit of plant and plant products. Guidance is provided by <u>Ordinance 385</u> of 25 August, 2021 of the Ministry of Agriculture and Livestock. Brazil does not require a letter of radioactivity attestation for each shipment. Please refer to the specific certificate of the product intended to be exported to Brazil to make sure the company complies to the attestation requirements.
