The Food and Agricultural Import Regulation and Standards (FAIRS) Certificate Report includes a list of the main certificates and permits needed to export food and agricultural products to South Africa. For a thorough understanding of South Africa's market access and certification requirements it is advisable to read the FAIRS Certificate Report in conjunction with the FAIRS Country Report.

## Executive Summary

South African import permits, health certificates, and phytosanitary permits are specific to the type of product and country of origin. It is recommended that exporters contact the listed South African certifying authority via the contact details provided in this report to obtain the relevant conditions for each shipment.

An import permit and veterinary health certificate are required when exporting animal and animal products to South Africa. Detailed information, including application forms for import permits for the exportation of animal and animal products to South Africa can be obtained from the Department of Agriculture, Land Reform and Rural Development (DALRRD) (see website: [DALRRD](#)). Veterinary health certificate must be issued by a recognized veterinary authority of the exporting country. South Africa is currently requiring that the veterinary health certificate be signed by the relevant officials before the products are shipped. The U.S. Department of Agriculture's Animal and Plant Health Inspection Service (APHIS) and Food Safety and Inspection Service (FSIS) are recognized certifying authorities by South Africa and provide inspection and certification services to American exporters. The procedures and requirements for exporting animal and animal products from the United States to South Africa can be obtained on the [APHIS website](#). Guidelines for exporting meat and poultry products may also be found on the [FSIS website](#).

Most plant products imported into South Africa require an import permit. DALRRD's Directorate of Plant Health is responsible for issuing import permits. APHIS is a recognized certifying authority by South Africa and provides inspection and certification services to U.S. exporters to confirm that the shipment complies with the required phytosanitary measures. The procedures to be followed when exporting plants and plant products to South Africa, as well as import permit application forms, can be obtained on the DALRRD website.

## SECTION IV: OTHER CERTIFICATION/ACCREDITATION REQUIREMENTS

**Signature of U.S. Certifying Official to be Applied Prior to Shipment:** South African regulatory authorities will not accept certificates endorsed by officials after the consignment has shipped. U.S. exporters should ensure that the products do not ship until after the certificate is signed by the competent or certifying authority.

**Exporter/Shipper Section:** The Exporter/Shipper section at the bottom of the FSIS Letterhead Certificates for poultry meat, pork and beef indicated must be completed regardless of the method of shipment. Any errors in this section may result in rejection by South African officials.

**Certificate of Origin:** The South African Declaration (or certificate) of Origin, Form DA-59, certifying the country of origin, description of goods, weight, etc., is required for shipments of some foodstuffs. South African Customs will notify the importer if a Form DA-59 is required and the importer will notify the exporter. When the form is required, exporters or suppliers must provide at least one original signed copy attached to the original commercial invoice. The Form DA-59 can be [downloaded here](#).

**Organic Certification:** South Africa has no regulations or state certification programs for organic products. Certification is driven by international standards and accreditation systems. The Foodstuff, Cosmetics, and Disinfectants Act (No. 54 of 1972) and the Consumer Protection Act (No. 68 of 2008) both clearly state that the consumer must not be misled. This means that where an ‘organic’ claim is presented on a label, suitable substantiation must be available upon request. The USDA National Organic Program is widely accepted for the certification of U.S. products intended for export into South Africa. Details and procedures to obtain organic certification under the USDA National Organic Program may be found on the [AMS website](#).

**Halal and Kosher Certification:** South Africa does not have an official state inspection or certification program for Halal or Kosher products. There are several voluntary organizations including the [National Independent Halal Trust](#), [South African National Halal Authority](#) and the [Kashrut Department of the Beth Din](#) of Johannesburg and Cape Town, which are responsible for the domestic certification in South Africa. While there are no Halal and Kosher state certification programs, imported products must not mislead consumers. As a result, where there are Halal and Kosher claims, suitable substantiation from reputable bodies may be requested at the port of entry.

**Attestation of radioactivity:** South Africa does not specifically require attestation of radioactivity for food and agricultural product imports. However, regulations under the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act 54 of 1972), stipulate that irradiated foodstuff, including imported irradiated foodstuff, may not be sold in the country unless the Minister or the Director-General of the Department of Health has in writing, approved the sale of such irradiated foodstuff. The authority for this has been delegated to the Director: Food Control of the Department of Health. Companies wishing to import irradiated foodstuffs into South Africa are advised to first contact the Directorate: Food Control ([Department of Health](#)) in this regard.
