#### **Report Highlights:**

This report only focuses on Spanish specific certification requirements when they differ or are additional to EU-harmonized certification. This report should be read in conjunction with the <u>EU-27</u> <u>FAIRS Export Certificate</u> report prepared by the FAS Office in the U.S. Mission to the European Commission (USEU).

#### **General information**

Being an EU member since 1986, Spain applies EU harmonized regulation on export certificates for plant or animal products whether or not they are intended for human consumption. However, in the absence of an EU-harmonized certificate, Spain may require certain specific health certificates and sometimes lack of specific details in the governing regulation also provides significant leeway for border inspectors to interpret.

Competent authorities on certificates vary depending on the type of products. While the Ministry of Health, Social Welfare and Gender Equality (MSSSI) is responsible for of products intended for human consumption, the Ministry of Agriculture, Food and Environment (MAGRAMA) is responsible for agricultural products for purposes other than human consumption.

There are a number of border inspections points in Spain that carry out <u>plant health inspection</u> (MAGRAMA) and veterinary inspection for products <u>intended</u> (MSSSI) and animal products <u>not</u>

intended (MAGRAMA) for human consumption.

# Section I. List of All Export Certificates Required By Spain (Matrix):

The imports of animal origin products, for purposes other than food (including live animals, semen, ovules and embryos) are subject to specific Spanish certification requirements. There is also a specific certificate for used kitchen oil intended for use in biodiesel production. Above listed Veterinary Certificates, requested by the MAGRAMA (Ministry of Agriculture, Food and Environment), require the signature of an Official Veterinarian.

\*Note: Cooking oil intended for biodiesel production can be imported under the requirements set by Spain since no harmonized requirements have been established yet. No declaration of processing method is required for this type of product.

#### **Section II. Purpose of Specific Export Certificate(s)**

Imports of food and agricultural products into Spain are not subject to special legislation other than that of the European Union. European Union legislation calls for many health and supervisory requirements that are meant to guarantee that imports meet the standards of production in Member States.

Spain, as an EU Member State, follows all rules and regulations that govern food legislation, including certification, within the European Union. While certification requirements are developed at the EU level, Spanish authorities are responsible for the enforcement of the regulations. Nevertheless, it is important to note that when EU-wide legislation is incomplete, not harmonized or absent, Spain might require certain specific health certificates. Additionally, sometimes applicable regulations provide significant leeway for border inspectors to interpret.

Certification requirements are developed at the EU level. However, Member State inspection services are responsible for enforcement. Spain is among the most vigilant of EU-27 Member States with respect to enforcement of the import requirements. While purely administrative mistakes such as minor typographic mistakes can sometimes be rectified, a zero tolerance policy can be assumed for those mistakes that affect the identity and tracability of the shipment (e.g. wrong establishment number).

According to General Principles for Certification, the certificate must be issued before the consignment to which it relates leaves the control of the competent authority of the country of dispatch. As a

consequence, Spain's Authorities have no tolerance for health certificates issued after the day of shipping.

#### **Special Import Permits**

#### Samples without Commercial value to Spain

For sanitary reasons, food products imported into the EU, even if they are not intended for commercial sale, must meet certain requirements on food hygiene and animal health.

On September 2011 Spain's Ministry of Health, Social Services and Gender Equality (MSSSI) implemented a procedure to authorize the import of samples of food products for human consumption without commercial value.

The same rules to commercial shipments apply to samples without commercial value regarding the Common Entry Document (CED published as <u>Annex II to Regulation 669/2009</u>).

To guarantee the access of samples without commercial value, prior or at the arrival of the product, the <u>part I of the Health Control Document</u> has to be presented and filled in specifying "Other" in the "For internal market" field

Other required documents include a copy of the invoice, documentation proving the non-commercial destination of the product (trade show information or research institute to which the samples are shipped), and the original <u>Declaration of Destination</u>.

#### Imports of biological material

The import of biological material has to be approved by the Ministry of Agriculture, Food and Environment (MAGRAMA). However, only an import permit is required. On February 2012 the MAGRAMA reviewed the procedure to authorize the import of biological material of animal origin for research purposes. More detailed information can be found in the <u>link</u> (Information only available in Spanish language) as well as the pertaining <u>form</u> to request the import permit to the competent authority (Subdirección General de Acuerdos Sanitarios y Control en Frontera).

The request must be prior to the arrival of the goods to the Border Inspection Post (BIP). Otherwise, they may be retained until the end of the process. The importing researcher investigator must complete the import of biological material for research form and present it to the competent authority.

#### • Imports of planting seeds to Spain

To import planting seeds to Spain a request has to be submitted by the local importer to Spain's Plant Varieties Authorities. Forms for notification or authorization, are available upon request at OEVV (Spanish Office for Vegetal Varieties). Contact data are:

The use of special required certification may also affect the control regime upon import. For instance, Almonds must be accompanied by a Voluntary Aflatoxin Sampling Program – VASP certificate issued by laboratories approved for the VASP program. The presence of such certificate determines the percentage of shipments tested upon entry in the EU.
