Report Highlights: Vietnam's Preferential Import Tariffs of some agricultural commodities including wheat, cheese, vegetable oils are amended. Import tax charged on wheat is raised to 5% from 0% while cheese will enjoy a slight tax reduction at 20% from the previous rate of 30%.

Report summary

The Decree No 137/2001/QD-BTC was signed by the Finance Deputy Minister Vu Van Ninh on Dec. 18, 2001, to amend preferential import tariffs of some agricultural commodities in chapter 4, 10, 15, 17, 19, 21.

Sub-headings are added to several ag. items in chapter 9, 10, 15, 17, 19 and 21 whether or not the tariff changed.

From January 15, 2002 wheat importers no longer enjoy import tax exemption on importing wheat as the new rate is set at 5% (see chapter 10). Preferential import tariffs charged on some vegetable oil products (see chapter 15) and preparation of cereals (see chapter 19) are also increased by about 10%. Import duty imposed on importing milk product (cheese) are slightly reduced to 20% from previous rate of 30% (see chapter 4%).
