## **Report Highlights:**

The Indonesian Ministry of Religious Affairs (MORA) notified a draft decree to the WTO TBT Committee on January 6, 2022, as G/TBT/N/IDN/140 regarding materials that are exempted from mandatory halal certification. The halal positive list includes ingredients considered to be halal by their nature that were not subject to any processing or were processed without the addition of food additives, food processing aids, or other materials; do not contain or come into contact with prohibited (*haram*); and are not dangerous. More than 4,000 chemical substances that serve as food additives and/or food processing aids are also included in this list.

This draft decree will also serve as a reference guideline for halal interlocutors by setting forth the specific ingredients that are exempted from halal certification requirements.
