Report Highlights:

On June 17, 2019, Japan notified the World Trade Organization of draft amendments to the maximum residue levels (MRL) for the agricultural chemical, Tetraniliprole, via <u>G/SPS/N/JPN/655</u>. There will be no public comment period established for this proposal as this proposal relaxes the regulation. "Other cruciferous vegetables" refers to all cruciferous vegetables, except Japanese radish roots and leaves (including radish), turnip roots and leaves, horseradish, watercress, Chinese cabbage, cabbage, brussels sprouts, kale, komatsuna (Japanese mustard spinach), kyona, qing- geng-cai, cauliflower, broccoli and herbs.
- 2. "Other herbs" refers to all herbs, except watercress, nira, parsley stems and leaves, celery stems and leaves.
