Report Highlights:

On December 31, 2021, the Ministry of Trade and Integration announced the first stage of 2022 meat and poultry quotas by HS code for historic suppliers (i.e., importers). The first stage approved the distribution of 2,835 tons of beef and 31,500 tons of poultry. The 2022 TRQ volumes and rates remain unchanged from those announced in 2021. U.S. exporters are advised that shipping, transportation, and customs clearance delays related to the global pandemic have been reported in several Baltic and Caspian Sea ports of entry, and along ground transportation routes in Eastern Europe, Russia, and Kazakhstan.

Background Information:

Beginning in 2010, tariff rate quotas (TRQs) were introduced for Belarus, Kazakhstan, and Russia by Customs Union Commission Decision No 130 dated November 27, 2009. Since then, the Eurasian Economic Commission (EEC) has approved TRQ volumes for specific beef, poultry, and pork products for Eurasian Economic Union (EAEU) members. As a EAEU member, Kazakhstan then approves specific volumes to “historical suppliers” (i.e., importers) who are authorized to import the product under the [preferential customs rate](#) of 15 percent of customs value for beef; and 25 percent, but not less than 0.20 Euros per kilogram for poultry. Any beef imported outside of the quota is assessed a duty rate of 50 percent of the customs value, but not less than 1.0 Euro per kilogram. Any poultry imported outside of the quota is assessed a duty rate of 80 percent of the customs value, but not less than 0.7 Euros per kilogram. Beef and poultry products are still under TRQ regimes, while pork quotas were cancelled in 2016.

On August 23, 2021, the EEC issued [Decision No. 102](#), “On Establishment of Tariff-Rate Quotas for Import of Certain Agricultural Goods into the Customs Territory of the Eurasian Economic Union (EAEU) in 2022” and “Volumes of Tariff-Rate Quotas for Import of these Goods in the Territories of the Eurasian Economic Union Member states.” The decision established TRQs and volumes for meat, poultry, and whey imports into the EAEU.

**Order of the Minister of Trade and Integration of the Republic of Kazakhstan No 670-NK,
December 31, 2021**

Tariffs Rate Quota Distribution

In accordance with part two of Article 16-1 of the Kazakhstani Trade Regulatory Act, the Eurasian Economic Commission's Decision of 17 August 2021, No. 102 "On the establishment of tariff quotas for certain agricultural products for 2022, imported to the Eurasian Economic Union territory, as well as the volumes of tariff quotas for these goods imported into the territory of the member states of the Eurasian Economic Union," ORDER:

1. Distribute the volume of tariff quotas between historical suppliers for 2022 (1-stage) according to the annex to this order.
2. The Department of Internal Trade of the Ministry of Trade and Integration of the Republic of Kazakhstan to ensure that this order is placed on the internet resource of the Ministry of Trade and Integration of the Republic of Kazakhstan.
3. Overseeing the implementation of this order should be placed on the supervising Vice-Minister of Trade and Integration of the Republic of Kazakhstan.

4. This order comes into force from the day it is signed.
