**Report Highlights:**

On April 19, 2022, the Ministry of Trade and Integration announced the second stage of 2022 meat and poultry tariff rate quotas (TRQs) by Harmonized System (HS) code for historic suppliers (i.e., importers). The second stage approved the distribution of 8,505 tons of beef and 94,500 tons of poultry. The 2022 TRQ volumes and rates remain unchanged from those announced the prior year. This report includes an unofficial translation of the decree with a list of historic suppliers.

**Background Information:**

On August 23, 2021, the Eurasian Economic Commission (EEC) issued [Decision No. 102](#), “On Establishment of Tariff-Rate Quotas for Import of Certain Agricultural Goods into the Customs Territory of the Eurasian Economic Union (EAEU) in 2022” and “Volumes of Tariff-Rate Quotas for Import of these Goods in the Territories of the Eurasian Economic Union Member states.” The decision established TRQs and volumes for meat, poultry, and whey imports into the EAEU.

On December 31, 2021, Kazakhstan’s Ministry of Trade and Integration approved the first stage of 2022 meat and poultry quotas of 2,835 tons of beef and 31,500 tons of poultry. **Order of the Deputy Prime Minister – Minister of Trade and Integration of the Republic of  
Kazakhstan No 195-NK**

**April 19, 2022**

**Tariffs Rate Quota Distribution**

In accordance with part two of Article 16-1 of the Kazakhstani Trade Regulatory Act, the Eurasian Economic Commission's Decision of 17 August 2021, No. 102 "On the establishment of tariff quotas for certain agricultural products for 2022, imported to the Eurasian Economic Union territory, as well as the volumes of tariff quotas for these goods imported into the territory of the member states of the Eurasian Economic Union," ORDER:

1. Distribute the volume of tariff quotas between historical suppliers for 2022 (2-stage) according to the annex to this order.
2. The Department of Internal Trade of the Ministry of Trade and Integration of the Republic of Kazakhstan to ensure that this order is placed on the internet resource of the Ministry of Trade and Integration of the Republic of Kazakhstan.
3. Overseeing the implementation of this order should be placed on the supervising Vice-Minister of Trade and Integration of the Republic of Kazakhstan.
4. This order comes into force from the day it is signed.
