Korea's Adjustment and In-Quota Tariffs for 2011

Report Highlights:

In late December, Korea announced changes to its 2011 tariff schedule for several agricultural products, which are actively used by the livestock feed and food processing industries. On January 25, the Korea Government added 5 agricultural items to the voluntary tariff-rate quota (TRQ) list to stabilize consumer prices. Finally, from February 1, frozen pork and pork belly will be added to the voluntary TRQ list to stabilize prices amid a supply shortage caused by the spread of foot-and-mouth disease in Korea. The lower tariffs and TRQ's for the additional items will remain in effect until June 30, 2011.

Adjustment Tariffs & Voluntary TRQs Announced for 2011

On December 28, 2010, the Ministry of Strategy and Finance (MOSF) announced tariff reductions of six months to one year on 67 items including selected agricultural, forestry and fishery products. The revisions in Table I and III are effective through calendar year 2011, while the revisions in Table II will be effective during the 1st half of 2011 (January 1 – June 30, 2011). These changes are expected to facilitate continued imports of U.S. agricultural products, particularly feed grains and food ingredients. The Korean Government has described many of the tariff cuts as anti-inflation measures. The most notable changes are listed below.

Feed Grains & Ingredients

- Animal & vegetable fat for feed: TRQ quantity sets at 50,000 MT for 2011 with an in-quota duty of 4 percent. Korea imported 13,332 MT from the United States out of a total 61,936 MT in 2010 (January November).
- Cotton seeds for feed: TRQ quantity sets at 160,000 MT for 2011 with an in-quota duty of 2 percent. Korea imported 65,112 MT from the United States out of a total 106,118 MT in 2010 (January November).
- Soybean oil cake for feed: TRQ quantity sets at 2,700,000 MT for 2011 with a 1 percent in-quota duty. Korea imported 383,505 MT from the United States out of a total 1,560,721 MT in 2010 (January November).

Food

- Guts and stomachs of animals for sausage casing: TRQ sets at 500 MT for 2011 with a 13 percent inquota duty. Korea imported 4,898 MT from the United States out of a total 10,148 MT in 2010 (January November)
- Maize for food processing: TRQ increased from 1,850,000 MT to 2,234,000 MT for 2011 with a 1 percent in-quota duty. Korea imported 1,239,490 MT from the United States out of a total 1,928,954 MT in 2010 (January November).
- Refined sugar for food processing: In-quota duty decreased from 35 percent to zero percent with an unlimited quantity until June 30, 2011.
- Fresh garlic: In-quota duty set at 10 percent with 26,467 MT of quota until June 30, 2011.
- Wheat or meslin flour for milling: In-quota duty set at zero percent for a 2,400,000 MT of quota from January 1 June 30, 2011.

Recent Developments

• On January 25, the Korean Government added 5 agricultural items (See the table II) to the voluntary TRQ list to stabilize consumer prices. The lower tariffs and TRQ's for the added items will remain in effect until June 30, 2011.
• From February 1, frozen pork and pork belly will be added to the voluntary TRQ list (See the details in the table II) to stabilize prices amid a supply shortage caused by the spread of foot-and-mouth disease in Korea. (See KS 1104)
