Report Highlights:

Slaughter and imports of pigs as well as pork production are up considerably in 1999. Export of pork and beef from intervention stocks to Russia surged due to use of export subsidies.

In 1999, the European Union (EU) donated 60,000 MT of mainly pork halves bone-in to Russia, out of a 100,000 MT package. The remaining 40,000 MT will probably be withheld due to Russian intervention in Chechnia.

Export subsidies for pork are likely to continue in 2000 and help raise domestic market prices.

Cattle and Beef

Available statistics on German livestock inventories indicate a further <u>decline</u> in <u>cattle stocks</u> as a response to low beef and cattle market prices in CY1999 which is expected to continue in CY2000. Nevertheless, numbers of bulls over two years and suckler cows increased as farmers anticipate a future improvement in prices.

<u>Slaughter numbers</u> and <u>production of beef and veal</u> declined in 1999, but less pronounced than in 1998. Production of beef and veal was about 1.35 million MT in 1999, two percent less than in 1998. Both slaughter (cattle supply) and production of beef and veal are expected to be only marginally lower in 2000.

Calf slaughter numbers are down considerably in 1999 from 1998 levels with the end of the pre-marketing aid scheme which offered farmers special payments when marketing calves at a premature age and lower weight. Subsequently, slaughter weights increased so that veal production is estimated at close to 1998 levels.

<u>Consumption</u> of beef and veal increased slightly in 1999 from 1.227 million MT to 1.238 million MT and is expected to fall short of this level in 2000 in response to higher beef/veal prices and lower demand for fresh and processed beef.

<u>Exports</u> of beef increased in 1999 (especially exports from intervention stocks to the major market Russia) whereas <u>imports</u> declined. Both <u>exports</u> and <u>imports</u> are expected to decline in 1999 and 2000.

Swine and Pork

Record <u>slaughter numbers</u> in 1999 increased meat supplies and lowered <u>hog and pork prices</u> in Germany. The dioxin scare in Belgium completely halted German exports of piglets to Belgium during the summer. These uncertainties curbed investments and so sow numbers and pig slaughter are likely to decline in 2000.

The EU remedies - aid to support private storage, high export subsidies and food aid for Russia - prompted high exports of pork, especially to Russia, and therefore helped relieve the market considerably. However, a reduction in export subsidies and a halt in private storage aid dampened market prices during the second half of 1999.

<u>Pig slaughter</u> in 1999 is estimated at 44. 4 million MT and <u>production of pork</u> at 4.0 million MT. Both pig slaughter and pork production are estimated to decline to 42.0 million and 3.9 million respectively in 2000 in response to still low market prices for pigs and pork and a reduction in investments in pig operations.

<u>Consumption of pork</u> rose to 4.7 million MT in 1999 and is forecast to decline slightly in response to higher consumer pork prices in 2000. <u>Private stocks</u> are expected at 20,000 MT in 1999, but to decline to 5,000 MT in 2000 as pork from private intervention is being sold successively onto the market.

Exports

Regular exports (versus food aid) will be key to sustainable recovery of both beef and pork markets in Germany. Beef may profit less from subsidized sales as the EU Commission reduces internal market support (Agenda 2000: Reduction in intervention prices in exchange for direct cattle payments) to increase competitiveness of beef exports. Exports of pork (especially to Russia which was Germany's second largest export destination in 1999) will depend strongly on export subsidies.

Intervention

<u>Public intervention stocks of beef</u> in Germany declined by 138,000 MT to 17,000 MT at the end of 1999. A full reduction is expected for early 2000. Most beef from intervention stocks was sold onto the domestic market, while small quantities were exported to third countries or shipped to EU countries. These sales from intervention depressed market prices throughout 1999.

Relatively high <u>private stocks of pork</u> in Germany (1999: 20,000 MT) are likely to dampen domestic pork prices at least for the first half of 2000.

Food Aid to Russia

The EU donated approximately 60,000 MT of pork to Russia in CY1999, out of a total anticipated food aid package of 100,000 MT of pork. Post believes the remaining 40,000 MT will probably be withheld from Russia in CY2000 as a result of Russia's military intervention in Chechnia.

Export to Russia and Pork Export Subsidies

German pork and beef exports to Russia surged in 1999 drastically in response to EU export subsidies. In 1999 (January through September), Germany already exported 89,000 MT of mainly pork halves in-bone to Russia, compared to only 13,000 MT during the same period in 1998.

Export subsidies are expected to continue at least during the first half of 2000 so that considerable quantities of subsidized pork are likely to be exported to Russia.

Sheep and Meat

German <u>production of lamb and meat from sheep, mutton and goat</u> is expected to rise only marginally in 1999 and 2000 to 45,000 MT as sheep raising is not a highly profitable venture because of low prices offered for meat and wool as well as strong import competition for these products.

Consumption of meat from sheep, mutton and goat is expected to rise noticeably in 1999 and 2000 to 100,000 MT. In fact, unlike other red meats where consumption declined, consumption of lamb meat rose continuously over the past years. In 1999, gross per-capita consumption was 1.2 kg, or 0.8 kg for human pre-capita consumption. This was 2.2 percent higher than in 1996 and 30 percent higher than in 1991 with 0.9 and 0.6 kg respectively. The reasons for this constant growth are threefold:

First, prices for lamb meat declined in real terms. Despite only a small growth in domestic production, the supply of

lamb meat increased significantly due to strong imports. New Zealand is the most important import origin and supplied 31 percent of lamb meat consumption in 1998, followed by the UK and Ireland. Additional suppliers are Australia and Uruguay. Prices declined along with strong supply.

Second, the Muslim population in Germany grew mainly due to immigration, and consumption of lamb meat figures prominently in their traditional diets.

Third, lamb meat profits from the attractive image of sheep being bred in a natural setting. Consumers especially appreciate that sheep are appropriately bred using natural feed, no antibiotics and other performance enhancers.

Imports of sheep and goats are expected to rise in 1998 and 1999; however, the general trend is for a decline in livestock trade due to disease concerns, exacerbated by BSE and scrapie scares. Exports declined in 1998 and are expected to rise in 1999.

Hides and Skins, Tallow and Grease

<u>Production</u> of <u>hides and skins</u> is expected to decline slightly in 1999 and 2000 because of reduced slaughter of cattle. Virtually all hides and skins from slaughtered cattle (including damaged or with lichen) are sent to tanneries for further processing (cleaning, preservation and pre-processing). They are then used in the leather industry for further processing into raw materials for finished products.

<u>Consumption</u> of hides and skins is expected to rise in 1999 and 2000 as the apparels and furniture industries in Germany recover from the recent recession.

<u>Imports</u> of hides and skins are estimated to rise to meet growing demand unmet by domestic supply. <u>Exports</u> are expected to be stable.

<u>Production</u> of <u>tallow and grease</u> may increase in 1999 and 2000 because of reduced slaughter for cattle, offset by much higher hog slaughter.

<u>Imports</u> are expected to drop slightly in 1999 and 2000 likely due to concerns about the future of raw material because of BSE related restrictions on final use and dioxin scares. The United States is expected to increase exports of tallow and grease as it is generally recognized among the industry as BSE free.

Germany is a major <u>exporter</u> of tallow and grease. Exports remain stable.

<u>Consumption</u> of tallow and grease dropped considerably in 1998 and is expected to rise only slightly in 1999 and 2000 due to public sensitivity to the use of by-products in feed. The German by-products industry seems to supply more and more foreign processors of tallow and grease and less domestically. Domestic users, i.e., manufacturers of cosmetics and hygiene articles, and feed manufacturers seem to use more raw materials from plant rather than animal origin.
