> Report Highlights: Poland's red meat output is expected to decrease 7 percent in 2000 and an additional 7 percent in 2001 in response to decreased exports of meat and meat products to FSU countries, increased feed costs and consumer preference for poultry meat vis a vis beef. In 2000, Polish exports of red meat are expected to drop by 25 percent due to lower demand from the FSU markets. Imports of pork are expected to grow in 2001 as a result of lower domestic supplies.

#### I. Situation and Outlook

Poland's red meat output is expected to decrease 7 percent in 2000 and another 7 percent in 2001. Pork and beef production will contract in response to decreased exports of meat and meat products to the Former Soviet Union (FSU), higher feed costs caused by the severe drought in 2000 and competition from poultry meat. The 2000 grain harvest is expected to be 13 percent below the previous year which will tighten feed supplies for cattle and swine. As a result, feed prices are expected to increase in the second half of 2000 and maintain low profitability of red meat production.

Cattle inventories are expected to continue to decrease in 2000 and 2001 in response to low milk and beef procurement prices. As demand for locally produced beef is very limited, farmers traditionally concentrate on fattening young cattle for export mostly to Italy as a side enterprise of their dairy operations. Most of the beef produced domestically is combined with pork to produce sausages or canned meat products and exported to FSU markets. Since high-quality corn-fed beef is not produced in Poland, U.S. choice beef has found a niche in premier Polish restaurants. The market could be potentially expanded to the large supermarkets which currently dominate the Polish retail market. Poland also represents a potential market for U.S. dairy and beef genetics. In 1999, imports of Holstein heifers from the Netherlands and Germany increased significantly reflecting higher interest of farmers in good genetics. Declining supplies of raw milk and beef will likely have a positive effect on the future profitability of the cattle sector due to an expected increase in procurement prices for milk and beef in 2001.

Beef production is expected to decrease in 2000 and 2001 as a result of lower cattle inventories and substitution of poultry meat. Over the last five years average consumption of beef decreased from 8.6 kilograms to 7.3 kilograms while consumption of poultry meat increased from 10.2 to 14.0 kilograms. Low prices for domestic

beef are expected to reduce imports. Beef offal, especially tripe, remains very popular. Poland imports an estimated 12,000 tons of tripe every year. Most tripe is imported from the United States and Australia. In 1999, Polish exports of beef decreased by 70 percent as a result of decreased demand from FSU countries. Exports are expected to remain low in 2000 and 2001.

Since 1995, Poland has maintained a tariff rate quota for beef. The quota for 2000 is 23,195 tons of beef (5,650 MT for HTS 0201 and 17,545 MT for HTS 0202). The tariff on in-quota trade for fresh, chilled and frozen beef is 30 percent. The over-quota tariff is 45 percent. There is a zero tolerance for presence of hormones in imported beef but Polish veterinary authorities <u>do not</u> require that beef originates from cattle which have not been treated with growth promoting hormones. Each imported shipment of beef is tested for presence of hormones. To date, no shipments have been rejected due to the presence of hormone residues.

In 1999, the GOP introduced levies for products imported below threshold prices. Beef was included in this group of products. While the tariff for in-quota imports remained unchanged, beef imported "out of quota" was subject to a 60 percent tariff plus an additional levy equal to the difference between the shipment price and the reference price. The reference price is calculated according to WTO safeguard requirements by the Polish Institute of Agricultural Economics.

Reduced demand for pork exports, low profitability of hog production and expected high feed costs should result in lower hog inventories in 2000. Reduced supplies of pork in the second half of 2000 will probably result in higher hog prices and, subsequently, higher hog inventories in 2001.

Pork output is expected to drop in 2000 and 2001 as a result of lower slaughter. Despite reduced output in 2000, pork consumption is expected to decline by only one percent because of lower Polish exports. Higher retail prices are expected in 2001, which could impact pork consumption.

In 1999, large scale slaughter companies purchased and processed about 54 percent of all hogs slaughtered. Small scale processors/butchers processed 33 percent of total production while 13 percent was slaughtered on farm. Total production of meat plants in 1999 was down by 6 percent. Large meat plants involved in shipping meat and meat products to the FSU countries suffered the most from the 1998 Russian crisis. It was easier for medium and small size meat plants to adjust to reduced exports and switch production to the domestic market. Adjustments needed to improve quality of products and packaging.

In 2000, imports of pork are expected to decrease reflecting lower demand for processing and limited exports to the FSU. Polish processors used to import trimmings or lower quality pork cuts and use them to produce sausages or canned meat exported mainly to Russia. Pork imports will also be constrained by the increased out-of-quota tariff which went up in 1999 from 60 percent to 83.3 percent and then was reduced to 76 percent in 2000. The total import quota for pork in 2000 is 46,480 tons. The within tariff quota is 30 percent. Imports of pork are expected to grow in 2001 due to lower supplies and higher prices on the domestic market.

It is estimated that exports of pork and pork products in 2000 will drop because of lower output and limited demand from FSU countries. Forty-three percent of pork exported in 1999 was halves originating from governmental stocks. In 1999, Poland also exported 26,100 tons of lard and grease and 6,800 tons of pork offal. Seventy-four percent of fats and 60 percent of offal were exported to FSU countries. Poland's live hog imports are limited to breeding hogs mainly from France. The export of canned hams to the United States continues to grow. Canned hams and shoulders exported to the U.S. come from USDA inspected plants and

are of generally high quality.

The Agricultural Market Agency (AMA) is responsible for stabilization of agricultural markets and governmental stocks of pork and other commodities. In 1999, AMA purchased 123,000 tons of pork from farmers and sold it to private companies for export. Private companies are responsible for exporting pork from AMA stocks. In order to obtain these stocks, the companies had to ensure that the pork was exported or processed and then exported. In the first four months of 2000, the AMA purchased 61,500 tons of pork halves and processed pork. It is expected that intervention purchases of pork will be continued by AMA until June 2000.

All meat shipments to Poland must be accompanied by a health certificate issued by a government-approved veterinarian from the exporting country. Products also must bear a label in the Polish language with the date of production clearly stated. In addition, suppliers have to check with importers Polish standards regarding exported products. Poland has a set of quality standards published as Polish Norms. Each norm has its number and is available in the Central Library of Norms in Warsaw. The same norms are set for storage conditions of meat and meat products and validity of the products depending on conditions and temperature of storage.

Please note: The following coefficients were used to re-calculate product weight of exported pork products to CWE: hams&shoulders 1.5; canned pork and sausages 1.39.
