Report Highlights:

On October 4, Japan's Ministry of Agriculture, Forestry, and Fisheries announced that it would decrease planned imports of non-fat dry milk (NFDM) by 6,000 metric tons (MT) in Japanese fiscal year 2019. Planned imports are now set at 14,000 MT, compared to the 20,000 MT originally announced in May. Industry sources report that lower than expected consumption of yogurt and other dairy products in the summer months pushed NFDM stocks higher.

General Information:

On October 4, 2019, the Ministry of Agriculture, Forestry and Fisheries (MAFF) announced that it would lower the volume of planned non-fat dry milk (NFDM) imports by 6,000 metric tons in Japanese fiscal year (JFY) 2019 which began in April 2019. MAFF had originally announced planned imports of 20,000 MT beginning in May 2019, already down 7,000 MT from the previous year (see JA9061). Planned NFDM imports for JFY 2019 are now set at 14,000 MT. The planned volume for butter imports remains unchanged at 20,000 MT.

According to MAFF data, NFDM stocks at the end of August were 76,000 MT, up 8.3% from the previous year. Industry sources report that mild early summer temperatures led to lower consumption of ice cream and yogurt which reduced demand for NFDM. Fresh milk consumption also declined, pushing domestic producers to send more milk to processing which boosted local production of butter and NFDM. Industry sources report that through the first half of JFY 2019 only 4,045 MT (around 20 percent) of the NFDM import quota had been successfully tendered.

Each year, MAFF sets the quota volumes based on its analysis of the supply and demand situation in Japan. Japanese imports of designated dairy products, including butter and NFDM, are conducted through a state-trading system operated by the Agriculture and Livestock Industries Corporation (ALIC). Tenders for NFDM will continue to be held every two months and butter every month. TRQ volumes for other dairy products, including natural cheese for processing, skimmed milk powder, evaporated milk, butter and butteroil, and certain whey products, were announced by Japan's Ministry of Finance on April 1, 2019 (see JA9047).
