Report Highlights:

The Secretariat of Commerce and Industrial Development (SECOFI) announced a preliminary resolution in the anti-dumping complaint against exporters of U.S. live hogs. SECOFI found under-pricing for live hogs from certain U.S. suppliers, as well as the threat of injury to the Mexican swine industry.

Introduction: This report summarizes a preliminary ruling published in Mexico's "*Diario Oficial*" (Federal Register) on February 1, 1999.

FAS/Mexico's Executive Summary: On February 1, 1999, the Secretariat of Commerce and Industrial Development (SECOFI) published in the Mexican *Diario Oficial* (Federal Register) a preliminary finding in the anti-dumping complaint against exporters of U.S. live hogs for slaughter (HTS#0103.92.99). SECOFI found under-pricing of US\$0.351 per kilogram, equivalent to approximately 48.13 percent, for live hogs from certain U.S. suppliers, as well as the threat of injury to the Mexican swine industry. The investigation continues, but effective February 1, 1999, imports from the U.S. are subject to countervailing duties equal to the difference between the export price and the SECOFI reference price of US\$1.08 per kilogram plus the current (in quota) import tariff of 8 percent applied to live hog imports from NAFTA countries.
