**Introduction:** This report summarizes a Official Mexican Standard published in Mexico's "Diario Oficial" (Federal Register) on April 18, 2001.

**FAS/Mexico's Executive Summary:** Mexico's Secretariat of Agriculture, Livestock, Rural Development, Fisheries and Foodstuffs (SAGARPA) announced in the "Diario Oficial" (Federal Register) the Official Mexican Standard, NOM-002-FITO-2000, establishing the Campaign Against the Coffee Berry Borer. The NOM applies to all who produce, manufacture, process or market these products. A summary of the key points follows below.

**Title:** Official Mexican Standard, NOM-002-FITO-2000, Campaign Against the Coffee Berry Borer.

## Background

NOM-069-FITO-1995 (Nov. 18, 1998)

The objective of the Norm is to prevent, destroy, control and reduce the coffee berry borer (*Hypothenemus hampei* Ferrari) in Mexico's coffee crops.

The following Phytosanitary regulations apply to the areas where the coffee berry borer has been detected and previously analyzed by the competent state government authorities and SAGARPA.

- a) Identification, diagnoses and sample recollection shall be done based on approved SAGARPA methodology and sent to an approved laboratory to be analyzed.
- b) Management of the pest will be done locally based on specific characteristics of the area. Sampling should be performed based on host species and will be determined by research institutions and validated by the technical committees of the Auxiliary Plant Health Organisms. Cultural practices will also be established based on the host.
- c) Destruction of the crop can be performed when SAGARPA determines there is a phytosanitary risk concerning the dissemination of the pest.
- d) Biological control of coffee berry borer can be done through predators: *Cephalonomia stephanoderis* or the pathogen *Beauveria bassiana*, The use of any biological control has to be done together with SAGARPA's Auxiliary Plant Health Organisms.
- e) Chemical control of the coffee berry borer can only be done according to CICOPLAFEST authorized products and dosis. Direct supervision by the technical committees of Auxiliary Plant Health Organisms shall be done to avoid inappropriate use of chemicals.

Growers must request SAGARPA officials or approved verification units to certify that the cultural practices and other regulations established in the Norm as follows.

Verification officers will fill out formats SV-01 for every grower per growing cycle concerning the cultural practices performed in accordance with this Norm.

The official Norm permits SAGARPA's regional offices and committees to establish sampling procedures, cultural practices, etc., according to characteristics of the region and crop.

The international sanitary certificate will be issued by SAGARPA at the place of origin, with the support of the results from approved verification units implementing the campaign against the coffee berry borer (SV-02).

SAGAR or approved verification units will verify compliance with this regulation. In addition, interested parties may request that verification units verify that establishments comply with the requirements contained in this NOM.
