Imports in MY98/99 were increased slightly as illegal imports were higher than expected. An estimated 200,000 tons of rice was smuggled into the Philippines in 1999. Domestic consumption in MY99/00 likewise was also raised due to higher supply.

Adequate rainfall and fewer typhoons in MY99/00 will expand area harvested and consequently rice production. Production and area harvested estimates are based on the most recent (April 2000) official GOP projections. Despite record production during the year, imports will still be required to satisfy food security requirements of the rapidly growing population. This will be in addition to an estimated 300,000 tons of rice illegally imported in MY99/00. The consumption level during the period was also raised to account for significant handling and storage losses as a result of what many consider to be over-importation in the face of record-level production in calendar year 1999. The U.S. import figure in the Jan.- Dec. row represents the volume contracted under the FY99 P.L. 480 Title I Agreement that has arrived early this year.

Production in MY00/01 will likely decline as the weather "normalizes" but is still expected to exceed MY98/99 levels. Imports are projected to reach a million tons in both MY00/01 and calendar year 2001. Imports from the U.S. will mainly be from the \$10 millionFY00 P.L. 480 Title I rice component scheduled for signing in July.
