Report Highlights:

This report replaces the report number MO2022-0003. The tariff rates for lentils and chickpeas have been updated based on new information from the Ministry of Agriculture. On January 3, 2022, the Government of Morocco (GOM) published Circular # 6279/222, announcing the required tariff changes under the U.S.-Morocco Free Trade Agreement (FTA) for Calendar Year 2022. The circular includes tariffs, tariff-rate quotas (TRQs), tariff-rate quota administration, agricultural safeguard measures, products covered by the preference clause, and allocation procedures.



On January 3, 2022, the Government of Morocco (GOM) published Circular #6279/222, announcing tariff changes as required under the U.S.-Morocco Free Trade Agreement (FTA) for calendar year 2022. The circular includes tariffs, tariff-rate quotas (TRQs), tariff-rate quota administration, agricultural safeguard measures, products covered by the preference clause, and allocation procedures.

Circular highlights include:

- 1) The phase out of tariffs on several products under the preference clause, listed below under Annex II, List 1.
- 2) Morocco has applied safeguard measures on whole chickens and turkeys (Annex 5). (Chicken parts, outside of quota, have had a safeguard applied since 2020. Turkey parts, outside of quota, have had a safeguard applied since 2021.)
- 3) Morocco has applied safeguard measures on pulses (Annex 5).
