




Nanchang to host the 2024 China Animal Husbandry Expo

CAHE 2024 will have a total exhibition area of 185,000 square meters, 14 indoor pavilions, seven outdoor sheds, and 5,000 square meters of bare-ground exhibition area. As one of China's largest and most influential trade shows in the animal husbandry industry, CAHE showcases various products with livestock production enterprises as the core exhibitors and covers related products and services of the upstream and downstream industry chain.
