Report Highlights:

Malaysia's CPO production rose 11 percent to 1.2 MMT in September, 2002. Carry-over stock level rose to 1.1 MMT at the end of September. The average local CPO price dropped moderately from US\$369/MT in September to US\$366/MT in October.

Executive Summary

Production

The Malaysian Palm Oil Board (MPOB) reported that total crude palm oil (CPO) production rose 11 percent from 1.1 MMT in the month of August 2002 to 1.2 MMT in September, bringing the total CPO production to 11.9 MMT for the whole year of 2001/02. Output in the Peninsula rose by 5.5 percent in September while East Malaysia's production rose by 20 percent. Compared to September 2001, output during September 2002 was higher by 13 percent. CPO output is experiencing a seasonal uptrend and Post now CPO production to reach 3.5 MMT during the Oct-Dec quarter.

Price

The monthly average CPO price dropped from US\$369/MT in September to US\$366/MT in October, reflecting the impact of the depreciation of the Indonesian rupee after the Bali bombing on the regional palm oil prices. For comparison, the average CPO price for September, 2001 was US\$226/MT. RBD Palm Oil FOB average price also dropped from US\$388/MT in September to US\$381/MT for October.

Stocks

The increase in CPO output more than offset the increase in overseas demand for palm oil. As a result, the PO stock level rose moderately to 1.1 MMT at the end of September. Since a further increase in CPO output is expected in the coming months, Post expects the carry-over stocks to increase to 1.25 MMT by the end of the Oct-Dec quarter.

Trade

Preliminary official PO exports increased from 890 TMT in August to 1.1 MMT in September.

Annual Situation

PS&D table for palm oil has been revised to reflect higher official CPO production, trade and carry-over stocks for 2001/02. Post has revised the 2002/03 CPO output to 12.9 MMT to reflect an improvement in CPO yields. Post also expects a higher PO imports. On the demand side, exports, domestic use and carry-over stock were revised upwards accordingly.
