Report Highlights:

On August 27, 2008, the Thai Government allocated a third round for its 2008 potato import quota. Imports of U.S. chip stock potatoes are likely to increase sharply in 2008 due to price competitiveness and good quality. A technical dialogue on phytosanitary requirements for U.S. seed potatoes to Thailand remains ongoing.

On August 27, 2008, Department of Foreign Trade (DFT), Ministry of Commerce, allocated an additional tariff rate quota (TRQ) of 5,024 tons for seed potatoes. This is the third round allocation for the 2008 import quota. As a result, the total allocation for seed potatoes and chip stock potatoes are currently 7,310 tons and 32,555 tons, respectively. The details of the 2008 quota allocation are presented below:

In general, the actual amount of imports is lower than the level of allocated quota since eligible importers (three potato chip manufacturers) normally report higher than actual demand in their quota request to allow for potential domestic production shortfalls. Domestic absorption requirements for potatoes continue to apply.

According to trade sources, imports of chip stock potatoes are estimated to increase by 5 percent in 2008 from 14,701 tons in 2007 to 15-16,000 tons in response to domestic crop damage and continued growth in the potato chip market. In the meantime, imports of U.S. chip stock continued to rise in 2008 due to price competitiveness and good quality. Trade sources estimate imports of U.S. chip stock may reach 8,000-9,000 tons in 2008.

For seed potatoes, trade sources report that potato chip manufacturers, which operate contract farming for domestic chip stock production, are seeking to source U.S. seed potatoes in 2008 more heavily due to the quality of U.S. seed potatoes and short supplies from Australia and U.K. Potential sales for U.S. seed potatoes are being limited by restrictive Thai phytosanitary requirements. The Animal and Plant Health Inspection Service (APHIS), U.S. Department of Agriculture (USDA), is currently engaged with Thai Plant Quarantine Officials to discuss the health protocol for U.S. seed potatoes.
