SUMMARY

The report introduces Vietnam's 2003 Preferential Import Tariffs (Pref.Rate) and Common Effective Preferential Tariffs (CEPT-rate) of Asian Southeast Nations (ASEAN) for major agricultural products from chapter 1 to chapter 23 (excluding chapter 13 and 14).

Vietnam's 2003 Preferential Import Tariffs

Pursuant to the Resolution No.399/2003/NQ-UBTVQH11 dated June 19, 2003 of the Standing Committee of the XIth National Assembly that amended and supplemented the Vietnam's Preferential Import Tariffs, on July 25, 2003, the Financial Deputy Minister Truong Chi Trung signed Decree No.110/2003/QD-BTC to promulgate the Preferential Import Tariffs. The new Decree replaces the Decree No.1803/1998/QD-BTC dated December 11, 1998 and all decisions amending and supplementing names, codes and tax rates of a number of commodities and commodity groups in the Preferential Import Tariffs issued by the MOF.

The new Preferential Import Tariffs will be effective from September 1, 2003

Vietnam has been applying the Preferential Import Tariffs for goods imported from countries that have the Most Nations Favor (MNF) status agreement with Vietnam since 1999. The Preferential rate is 50% less than the normal rate. Currently, Vietnam has the MNF agreements with sixty one countries including the United States of America.

Vietnam's 2003 CEPT's rates

On July 1, 2003 Vietnam's Prime Minister Phan Van Khai signed Decree 78/2003/ND-CP on the list of commodities and their tax rates for implementing the Agreement on Common Effective Preferential Tariffs (CEPT) of Asian Southeast Nations (ASEAN) for the period 2003/06.

The new decree will effective from July 1, 2003 and replaces the Government Decree No.21/2002/ND-CP dated February 28, 2002 on Vietnam's 2003 CEPT list (see VM2016).

The number of items under the 2003 CEPT list increased to 10,689 from 6,514 items of the 2002 CEPT list. These items will have tax rates less than 20%. The CEPT rates of nearly 8,000 items will have the tax rate between 0-5% by 2003 and the tax rates of all items will be cut down to 0-5% by 2006.

The new items added to the 2003's CEPT list included vegetable oil, beverages, confectionery, processed vegetables and fruits and wooden products.

ASEAN countries include Brunei; Myanmar; Cambodia; Indonesia; Laos; Malaysia; Philippines; Singapore; Thailand and Vietnam.
