## **Report Highlights:**

On January 21<sup>st</sup>, the Food Agency of the Ministry of Agriculture, Forestry and Fisheries (MAFF) conducted its sixth and the final Ordinary Minimum Access rice tender. A total of 96,100 metric tons of foreign rice was contracted with the United States accounting for 44,000 metric tons, or 45.8 percent of the total. This tender concludes all required minimum access tenders for Japan Fiscal Year 1999 (April 1999 - March 2000). Total U.S. market share for JFY 1999 amounted to 47.9 percent (312,826 metric tons) for the total minimum access volume of 653,100 metric tons.

### Executive Summary

On January 21<sup>st</sup>, the Food Agency of the Ministry of Agriculture, Forestry, and Fisheries conducted its sixth and the final Ordinary Minimum Access (OMA) rice tender for the Japanese Fiscal Year 1999 (April 1999 - March 2000). A total of 96,100 tons of foreign rice was contracted with the United States accounting for 44,000 metric tons, or 45.8 percent. Also contracted was rice from Thailand - 23,200 tons (24.1 percent), Australia - 20,000 tons (20.8 percent), and China - 8,900 tons (9.3 percent). The weighted average of the successful bid price was 40,103 yen per metric ton. Additional details for the sixth OMA tender are provided below:
