### Russian Imports Plummet in Early 2004

**Report Highlights:**

Russian imports of meat fell dramatically in the first quarter of 2004 due to poor implementation of TRQs on beef and pork and a quota on poultry meat. Import volumes and values fell by almost 50 percent for every major meat category. Total Russian imports of meat in Q1 2004 were almost \$250 million less than the same period in 2003.

Russian imports of meat fell sharply during January-March 2004, compared with 2003, due to poor implementation of the TRQ on beef and pork and the quota on poultry meat. Russian meat imports from January – March 2004 were down by approximately 45 percent in both volume and value terms compared to the previous year. The lack of import permits during Q1 2004 cost exporters almost \$250 million versus 2003.

As noted in FAS GAIN Report RS4029, the Russian Government implemented new regulations regarding the distribution of the 2004 shares to Russian importers that had “historic” levels of trade. Due to poor implementation of the methodology for calculating import shares, confusion reigned in the first several months of 2004 as the Russian Government repeatedly issued, cancelled, and then re-issued lists of eligible Russian importers. As a result of the confusion caused by the Russian Ministry of Economic Development and Trade, import licenses were, at best, haphazardly provided to importers during this period. As a result, Russian imports of meat products in all major product categories fell by an average of approximately 50 percent versus the same period in 2003 (when no limitations were in place). While imports began to pick up starting in April, significant amounts of trade were lost during that period. Importantly, losing one quarter of the year may affect some countries’ ability to completely fill their 2004 quota.

Shipments of meat and poultry are reported to have returned to normal levels beginning in April 2004. According to Interfax, Customs data shows that total poultry imports reached 98,000 MT in April, as companies try to compensate for the permit problems of Q1.
