# **Report Highlights:**

On April 6, 2020, the Russian Government issued decree No. 453, amending the list of agricultural products that are subject to Russia's food ban to exclude some whey powder (from HS heading 0404) from the ban. This is a second relaxation of the food ban since 2019 when chickpea seeds and lentil seeds were excluded from the ban under certain conditions according to the Russian Government decree No. 1293 of October 7, 2019. This report contains unofficial English translations of both decrees mentioned above, as well as Russia's food import ban, listing the countries and products covered, as it currently stands.

### **General Information**

On April 6, 2020, the Russian Government issued decree No. 453, amending the list of agricultural products that are subject to Russia's food ban to exclude 90 percent demineralized whey powder (HS heading 0404) used specifically for the production of baby food from the ban. The decree also mandates that the Ministry of Agriculture shall establish a procedure to verify intended use and determine the volume of such imports. The document shall come into effect on April 16, 2020.

This is a second relaxation of the Russian food ban since 2019 when chickpea seeds and lentil seeds were excluded from the ban under certain conditions according to the Russian Government decree No. 1293 of October 7, 2019. In particular, chickpeas and lentils for sowing were added to the exceptions from the banned category "vegetables and edible root and tuber crops." To be excepted from the ban, the chickpea and lentil seeds must be either included in the Russian federal register of selection achievements allowed for use (which is currently a barrier to trade with Russia as fewer imported seeds have been granted registrations in recent years), or imported for scientific research, state testing and production of seeds for export from Russia.

Additionally, the decree mandates that the Ministry of Agriculture shall establish a procedure to verify intended use and determine the required import volume of the following seeds to be imported for scientific research, state testing and production of seeds for export from Russia:

- seed potatoes (EAEU HS code 0701 10 000 0),
- onion sets, fresh or chilled (0703 10 110 0)
- dried sweetcorn, hybrid, for sowing (0712 90 110 0),
- peas, 'pisum sativum', dried and shelled, for sowing (0713 10 100 0),
- dried, shelled chickpeas 'garbanzos', whether or not skinned or split (0713 20 000 0),
- dried, shelled lentils, whether or not skinned or split (0713 40 000 0).

# On Amending the Attachment to the Decree of the Government of the Russian Federation No. 778 of August 7, 2014

The Government of the Russian Federation decrees:

- 1. To approve the attached amendments in the attachment to the decree of the Government of the Russian Federation No. 778 of August 7, 2014 "On the Measures to Implement the Decrees of the President of the Russian Federation No. 560 of August 6, 2014, No. 320 of June 24, 2015, No. 305 of June 29, 2016, and No. 293 of June 30, 2017, and No. 420 of July 12, 2018, and No. 293 of June 24, 2019" (Collection of laws of the Russian Federation, 2014, No. 32, art. 4543; No. 34, art. 4685; 2015, No. 26, art. 3913; No. 33, art. 4856; No. 39, art. 5402; 2016, No. 10, art. 1426; No. 23, art. 3320; No. 28, art. 4733; No. 38, art. 5546; No. 44, art. 6142; 2017, No. 22, art. 3161; No. 28, art. 4164; No. 45, art. 6659; 2018, No. 31, art. 4996; 2019, No. 26, art. 3457; No. 41, att.5724.)
  - 2. The Ministry of Agriculture of the Russian Federation shall:

develop and approve a procedure for confirmation of intended use of the imported product – 90 percent demineralized whey powder, intended for the production of dry baby formula (breast milk substitutes,) as provided by the attachment to the decree of the Government of the Russian Federation No. 778 of August 7, 2014 "On the measures to implement the Decrees of the President of the Russian Federation No. 560 of August 6, 2014, No. 320 of June 24, 2015, No. 305 of June 29, 2016, and No. 293 of June 30, 2017, and No. 420 of July 12, 2018, and No. 293 of June 24, 2019" and classified under the EAEU HS code 0404;

approve the volume of the product specified in the second sub-paragraph of the present paragraph to be imported into the Russian Federation in 2020.

3. The present decree shall apply through December 31, 2020.

The Government of the Russian Federation decrees:

- 1. - a) develop and approve a procedure for confirmation of intended use of imported products, in which shipments of seeds are intended for scientific research, stated testing, and production of seeds for exports from the Russian Federation, as provided by the attachment to the decree of the Government of the Russian Federation No. 778 of August 7, 2014 "On the Measures to Implement the Decrees of the President of the Russian Federation No. 560 of August 6, 2014, No. 320 of June 24, 2015, No. 305 of June 29, 2016, and No. 293 of June 30, 2017, and No. 420 of July 12, 2018, and No. 293 of June 24, 2019" (as amended by the present decree )and classified under the EAEU HS codes 0701 10 000 0, 0703 10 110 0, 0712 90 110 0, 0713 10 100 0, 0713 20 000 0, and 0713 40 000 0;
- b) approve as needed the volume of the products specified in the sub-paragraph a) of the present paragraph to be imported into the Russian Federation.
