
Report Highlights:

The Korean government implemented a volume-based liquor tax for beer on January 1, 2020. All beer will now be subject to 830.3 won (72 cent) per liter liquor tax. This tax will replace the previous 72 percent value-based liquor tax for beer. The policy change will reduce the cost of higher value beers in the market, including imported U.S. craft beer.

The Korea Ministry of Trade, Industry and Energy (MOTIE) announced on December 30, 2019 that the liquor tax for beer will be changed from a value-based system to a volume-based system on January 1, 2020. Under the volume-based liquor tax, any beer, regardless of production cost or retail price, will be subject to the same 830.3 won (72 cent) per liter liquor tax. Beer distributed to restaurants and bars in kegs will be taxed at 664.2 won per liter (a 20 percent tax discount) until the end of 2022, after which it will be taxed the same as other beer.

The policy change will benefit higher quality beer, including imported U.S. craft beer, as higher priced products will see the largest decline in liquor taxes. Most mass-produced lower price products will see a minimal change in taxes. Beer priced over 35 cents per 12 oz container (CIF for imported or ex-brewery for locally brewed beer) will benefit from the new tax policy, while beer priced less than 35 cents will face a higher tax bill.


The Korean beer market has grown steadily in recent years, outpacing sales of spirits. Imported beer sales have expanded faster than local beer sales as consumers demand more quality and more diverse beers, although Korea has a growing craft beer industry as well.

U.S. beer exports to Korea totaled \$53 million in 2019 through October, up 55 percent from the same period in 2018. The increase in trade has not shown up yet in Korean import statistics, indicating that some of the imported U.S. beer may still be in bonded warehouses. Korea is the fourth largest export market for U.S. beer, and the U.S. is the fourth largest supplier of imported beer to Korea. The table below provides an example of how the tax change will impact a CIF \$1 twelve-ounce container of beer from the United States. Under this scenario, cost of imported U.S. beer after tariff and taxes will decline by 31 percent. The price of a \$2 twelve-ounce container of beer would decline by 40 percent.
