**EU ANNUAL REPORT ON US TRADE BARRIERS** - On November 20, the European Commission released its eighteenth annual report on barriers to trade and investment in the US. The report is available at the Internet at http://europa.eu.int/comm/trade/bilateral/usa/usa.htm.

**ENLARGEMENT -** The EU Foreign Ministers at the November 18 General Affairs Council (GAC) formally decided that the EU would be enlarged on May 1, 2004. While initially, the date of January 1, 2004 was always mentioned as the accession date, the Danish Presidency reasoned that ratification by CC-10 parliaments would "take some time" so January 1 was "too optimistic." The EU's 15 member states and the 10 candidate countries hope to reach agreement on enlargement at the EU Summit in Copenhagen on December 12-13. Even with the agreement between EU 15 member states on capping the agriculture budget until 2015, agriculture subsidies still tends to be a sticking point. While no one expects enlargement to be derailed over "50,000 tons of dairy quota" to quote one Commission official, hard negotiations and last minute bargaining up to and during the Copenhagen summit can be expected.

**EU-CHILE AGREEMENT -** The EU and Chile signed an Association Agreement on November 18. According to a Commission press release the trade section covers all the areas of trade and goes well beyond EU and Chile's WTO commitments. The agreement includes a Wines and Spirits Agreement that will recognize each parties' protected names and oenological practices. Also, an SPS Agreement covering trade in animal. **ANIMAL WELFARE** - On November 19, the European Commission released a report on "Animal Welfare Legislation on Farmed Animals in Third Countries and the Implications for the EU". The report compares animal welfare standards in the European Union with standards in third country trading partners and analyzes ways to avoid potential competitive disadvantages as a result of disparities in measures. EU STANDS BY FISHERMEN, FISH AND SHELLFISH FARMERS - On Tuesday, November 19, 2002 the tanker 'Prestige', which had been leaking oil off the north-west coast of Spain sank. The tanker was carrying approximately 77,000 metric tons of heavy fuel oil and experts are worried that if the oil reaches the coastline, it may be years before certain species recover. On November 20, EU Fisheries Commissioner Franz Fischler declared "I feel for the fishermen on the Spanish coast. Through no fault of their own, they now are part of this disastrous oil spill, and their livelihoods are threatened. The EU won't let them down. Fishermen who have to stop their fisheries activities because of this ecological disaster can count on EU aid to compensate them for the temporary cessation of their activities. Spain has earmarked 117.7 million euros under the Financial Instrument for Fisheries Guidance for this purpose."

EU PREPACKAGING SIZES UNDER REVIEW - EU legislation on prepackaging sizes can be simplified and improved. In order to make justifiable policy choices the European Commission has launched two complementary on-line consultations, consisting of a survey questionnaire and a discussion forum. The Commission services have also produced a working paper to guide the debate. The working paper concludes that in general there does not seem to be a public interest that justifies fixing sizes by means of legislation. Stakeholder views gathered so far show that next to unit prices, consumers want standard sizes that better fit their needs. Manufacturers' views vary. Some sectors with fixed sizes want to keep them, while other sectors consider free sizes to be essential to innovation. Other sectors that were traditionally in favor of fixed sizes want to move to free sizes. (Also see GAIN Report E22115)
