Report Highlights: Total 2000 Brazilian unmanufactured tobacco production estimate revised upward to 589,000 MT, farm sales weight, due to record yields in southern Brazil crop. Marketing of the 2000 crop is virtually over and producers' price was up 7 percent relative to the last crop. Total MY 2000 unmanufactured tobacco exports estimated at 350,000 MT, up 7,000 MT, from the revised 1999 export estimate. The cigarette production estimate for MY 1999 revised downward to 108 billion pieces, due to lower than expected exports and domestic consumption. Cigarette production for MY 2000 is projected stable at 110 billion pieces.

Executive Summary

Total 2000 Brazilian unmanufactured tobacco production estimate revised upward to 589,000 metric tons (MT), farm sales weight, due to record yields in the southern Brazil crop. Marketing of the 2000 crop is virtually over and producers' price was up 7 percent from last season. Total MY 2000 unmanufactured tobacco exports are estimated at 350,000 MT, up 7,000 MT, from the revised 1999 export estimate. The cigarette production estimate for MY 1999 has been revised downward to 108 billion pieces, due to lower than expected exports and domestic consumption. Cigarette production for MY 2000 is projected stable at 110 billion pieces.

Production

Production and Crop Area

The Agricultural Trade Office (ATO)/São Paulo estimate for total Brazilian unmanufactured tobacco production for marketing year (MY) 2000 (January-December) has been revised upward to 589,000 metric tons (MT), farm sales weight (FSW), a 9 percent increase compared to previous estimate, due to higher than expected production in southern Brazil. This region contributed 540,000 MT, up 48,000 MT from previous estimate and down 6,000 MT from previous season. Industry contacts report the 2000 northeastern tobacco crop estimated at 49,000 MT.

ATO/São Paulo estimates total MY 2000 area planted to tobacco unchanged at 329,500 hectares (HA), and down 16,000 HA from the previous crop. According to post contacts, in spite of the lower area planted to tobacco for the 2000 southern crop, the higher volume of harvested product is a consequence of good weather conditions that prevailed during the production season (colder nights and mild days) which extended the development cycle of the plants. The use of "floating system" seedlings is also reported as a positive factor for improved productivity. Additionally, tobacco growers have been more conscious regarding crop management, thus improving their agricultural practices. The southern harvest season was over in late April and currently nearly all tobacco has been purchased by manufacturers. According to industry contacts, the quality of the 2000 crop southern crop is average and slightly above last season.

No forecast has yet been done for the MY 2001 southern crop. Currently, tobacco growers are managing the seedlings to be planted in the next couple of months. According to contacts, area planted to tobacco for MY 2001 will likely remain stable. The table below shows Brazilian tobacco production estimates for MY 1998, 1999 and 2000 for southern tobacco and northeastern Brazil by type of tobacco.

Final figures for the number of tobacco growers and curing barns in southern Brazil, as reported by the Brazilian Tobacco Growers Association (AFUBRA), follow. Note that MY 2000 figures show a 10 percent reduction in the number of growers eligible to plant tobacco in the integrated system adopted by local tobacco processing companies. This system reflects the partnership between growers and tobacco companies, in which the companies provide producers with seeds and other production inputs and supplies (plastic bags), and facilitate financing. The reduction in the number of tobacco growers is due to the tobacco companies planning strategies, which set the area to be cultivated for each season based on projected requirements, and their selection of the better growers to participate.

According to the 1999/2000 AFUBRA survey, the average area planted to tobacco on a farm was 2.6 HA, representing approximately 14.9 percent of the total area of the farm. The table below shows the patterns of land utilization on a typical farm in southern Brazil. As reported by AFUBRA, all other activities are mainly for family subsistence. The survey, as shown below, also points out the number of tobacco growers by size of farm, indicating that 25.1 percent of the growers do not have a property of their own, and 30.5 percent of the growers have fewer than 10 HA, indicating that the tobacco crop is mainly planted by small growers.

Inputs

The level of input utilization for the 2000 crop in southern Brazil remained at normal levels. According to post contacts, the use of nitrogen is expected to decrease somewhat for the 2001 crop to control alkaloid content in nicotine.

Yields

Tobacco yields for southern and northeastern Brazil, as well as tobacco yields by variety, follow. Tobacco yields for the 2000 southern crop recorded 2,160 KG/HA, up 5 percent from the previous crop. According to contacts, the record yield is a result of good weather conditions that prevailed during the production season (colder nights and mild days), the use of "floating system" seedlings and the selection of growers more conscious of the need for good crop management.

Prices

As a result of the price negotiations between growers and tobacco processors, tobacco prices increased 7 percent for the 2000 crop, in local currency terms, in relation to last season. The local currency is the "Real." Tobacco prices by grade for MY 2000 and average prices received by producers for MY 1999 and 2000 follow.

Consumption

Total unmanufactured tobacco consumption for MY 1999 has been adjusted downward to 106,150 MT, a 4 percent reduction compared to the previous estimate, due to lower cigarette production. Total unmanufactured tobacco consumption for MY 2000 has been revised downward to 107,750 MT, down 3,800 MT from the previous estimate due to an expected reduction in cigarette output. Note that tobacco consumption data in this report are based on cigarette production plus an estimate for twist tobacco and cigars. The conversion factor used is 0.8 grams of unmanufactured tobacco per cigarette produced.

Utilization Patterns

Flue cured and light air cured tobaccos are used to manufacture most cigarettes in Brazil. Burley is used mainly in blends to improve the taste of domestic cigarettes.

Trade

Exports

The total Brazilian unmanufactured tobacco export estimate for MY 1999 (January-December) has been revised upward to 343,000 MT, a 8 percent increase compared to previous estimate, based on recent data from the Brazilian Secretariat of Foreign Trade (SECEX). ATO/São Paulo estimate for total unmanufactured tobacco exports for MY 2000 is 350,000 MT, up 30,000 MT from the previous projection. According to industry contacts, although there is a projected decrease in world tobacco leaf consumption, the demand for Brazilian tobacco was strong during the first semester of the year. The Brazilian product has been very competitive in international markets since the devaluation of the Real. Post contacts also report that there has been a delay in shipping the Brazilian product due to the political problems in Zimbabwe. Buyers have opted to transport their shipments from Zimbabwe in advance to protect their purchases from any future incident that might occur there. Industry contacts also reported that shipping costs have increased at least twice from 1999 to 2000. The tables below show total unmanufactured tobacco exports for MY 1998 and 1999 (January-December (CY)) and 1999 and 2000 (January-April) by type of product (see Policy for NCM descriptions) and by country of destination as reported by SECEX.

Production

The MY 1999 Brazilian cigarette production estimate has been revised downward to 108 billion pieces (BP), based on recent information from post contacts. Brazilian cigarette production for MY 2000 is estimated at 110 BP, up 2 BP from previous season.

Consumption

The Brazilian cigarette consumption estimate for MY 1999 has been revised downward to 101.7 BP, according to trade sources. Cigarette consumption for MY 2000 is estimated at 104 BP. Contrabanded cigarettes, especially from Paraguay, which are marketed locally at significantly lower prices, represents the major concern and competition for Brazilian cigarette companies' local sales. According to the tobacco industry, approximately 35 percent of the actual domestic consumption results from contrabanded cigarettes.

Prices

Retail cigarette prices per pack of 20 pieces vary between R\$ 1.10 and 2.50 for Souza Cruz (British America Tobacco) and R\$ 1.10 and 2.15 for Philip Morris depending on the brand. Prices have been steady since mid-July 1999.

Trade

Exports

Total Brazilian cigarette exports for MY 1999 are estimated at 6.3 BP, down 1.2 billion from the previous estimate, based on recent information from the Brazilian Secretariat of Foreign trade (SECEX). The cigarette export estimate for MY 2000 is likely to remain stable at 6 BP. The sharp decrease in cigarette exports during 1999 and 2000 is a result of the 150 percent tax imposed on exports to inhibit cigarettes exported to Paraguay from being contrabanded back into Brazil. Total manufactured tobacco exports for MY 1998 and 1999 by country of destination, as reported by SECEX, follow.

Marketing

The Ministry of Health sent a proposal to the Brazilian Congress forbidding all types of radio and television commercials for cigarettes. The proposal will be voted next August. Both tobacco growers and manufacturers allege that such measure will promote a negative social and economic impact to the tobacco industry. The Brazilian Radio and Television Association advocates that commercials should be allowed from 12 am to 5 am.
