**Report Highlights:** 

France is a minor producer of tomatoes, and there is no trade for tomatoes and products between France and the United States. Total French tomato production amounted to 851,801 MT in 2000, including 537,832 MT for the fresh market and 313,969 MT for processing. In 2001, the forecast is for an increase in tomato production for both the fresh and processing markets. This is expected to result from the growing acreage of tomatoes in greenhouses. In addition, the reformed Common Organization of the Market for fruits and vegetables set by the EU increased the production threshold for tomatoes for processing for France from 2000 to 2001.

### **Executive Summary**

Total French tomato production amounted to 851,801 MT in 2000, including 537,832 MT for the fresh market and 313,969 MT for processing. In 2001, the forecast is for a slight increase in both fresh sale production due to the growing percentage of tomatoes grown under greenhouses, which have higher yields than tomatoes grown in open fields, and production for processing, as a result of the increased production threshold for France set by the reformed EU Common Organization of the Market for fruits and vegetables. Deliveries of fresh tomatoes for processing were 313,969 MT in 2000, and are likely to increase to 320,000 MT in 2001.

#### **Tomatoes for the Fresh Market**



French household consumption amounted to 323,000 MT in 2000, a 4 percent decline from 1999, and sales amounted to FF 4 billion (USD 561 million), up 13 percent from 1999. The average retail price for fresh tomatoes in France was therefore 12.4 FF per kg (1.75 USD/kg). Tomato is French consumers' preferred vegetable. The average per capita consumption amounted to 13 kilograms from 1996 to 1999, and 95 percent of French households purchase tomatoes. The French tomato market in 2000 included a large segment for round tomatoes (62 percent), followed by branched tomatoes (29 percent), long tomatoes (4 percent), and cherry tomatoes (4 percent). In 2000, supermarkets totaled 64 percent of tomato sales, 10 percent were sold at hard discounters and the remainder was sold at street markets and special stores.



Tomato consumption is seasonal, since 60 percent of the purchases traditionally take place from April to August. However, French consumers tend to extend their purchasing season for tomatoes to the fall, as indicated in the opposite graph.

France has a significant trade deficit in fresh tomatoes. France's leading suppliers are Spain and Morocco, which supplied 81 percent of the French market in 2000. Spain replaced Morocco as the leading tomato supplier for France in 2000, because Morocco agreed to limit its tomato exports to the EU to 145,676 MT, per the request of Spain.

#### **Tomatoes for Processing**

France is a minor producer of processed tomato products. The EU threshold for France set in 2001 by the EU under the reformed common market organization (CMO) for fruits and vegetables amounted to 401,600 MT, i.e., 5 percent of the total EU threshold for tomatoes for processing. Higher quotas exist for Italy, Greece, Spain and Portugal, with 52, 15, 15 and 13 percent of the EU quota, respectively.

Under the reformed CMO, the minimum price for fresh tomato to be processed is terminated. This price is now set by the producer organization (PO) and the processor. Only tomatoes delivered by a PO and corresponding to some quality standards will get subsidies from the EU. These subsidies will be received by the POs, which will be charged with distributing the funds to their members. Whatever the finished product, the EU subsidy will amount to 34.5 Euros per MT. There are 10 POs and producer groups of tomatoes for processing in France: Camaret, Apto-2, Apaaf, Copatomate, Val Soleil, Audecoop, Sicatom, Uniproledi, Maïsadour, and Capel-la Quercynoise. 80 percent of tomatoes grown for processing are located in southeastern France.
