**Report Highlights:** 

MY2001 tomato paste production is now estimated at about 170,000MT significantly less than 260,000MT of last year. Extremely dry summer, competition from other crops and financial problems of some of the processors are reasons for the decline. Turkish tomato paste exports for MY2000 are down as well to 134,914MT compared to 190,638MT a year before. MY2001 exports are expected to decline even further. The E.U. still refuses Turkey's utilization of its 38,400MT duty-free quota for tomato paste due on going dispute over E.U. duty-free meat exports to Turkey.

## **Executive Summary**

MY2001 production of tomato paste is estimated to be down significantly to about 170,000MT tons compared to 265,000MT in MY2000 and 320,000MT in MY1999. Many factors affected production. Dissatisfaction of farmers on the return of industrial tomatoes caused industrial tomato planting area to decline. Meanwhile, extremely dry summer caused the yield to decrease and the growing the season to shorten. In addition, high domestic interest rates caused production costs of processors to increase and contributed to the financial strains that they are facing. Also, following last year's world wide large production of tomato paste and accompanying lower world prices, some local processors are in financial strain. Some processors are reportedly not able to pay to farmers. Due to loss of income, farmers in the main industrial tomato growing regions shifted out of tomato production into other cash crops such as corn, vegetables, wheat and red peppers.

After many years of continued increases in domestic consumption, the economic crises that Turkey is facing has caused domestic consumption of tomato paste to decline about 13 percent to 105,000MT in MY2000. The domestic consumption is expected to remain about that level in MY2001 as well.

Available data indicate that during the MY2000 exports of Turkish tomato paste declined to 134,914MT compared to 190,638MT in MY1999. Japan was the leading importer with 29,503MT followed by Russia with 23,490MT -- despite the increasing competition from Iran in this market. Turkish paste exporters are said to have lowered their prices to US\$600 per ton to achieve the above quantity. China with its low-priced tomato paste continues to be a strong competitor for Turkish exports in the Far-Eastern market. Exports in MY2001 are expected to deline even further to an estimated 100,000MT.

Larger tomato paste production in the past two years has kept stocks at normal levels. But MY2001 year-end stocks are expected to be much lower than usual levels due to lower production. Also, retail prices for processed tomato products increased about 150 percent -- significantly above 67 percent annual inflation -- during the last twelve months due to the lack of supplies.

The E.U. is not permitting Turkey to utilize its 38,400 MT duty-free paste export quota due to disagreements over Turkey's meat import obligation. Negotiations are still continuing with the E.U. to prevent the 15 percent import tax on Turkish tomato paste.
