## **Executive Summary**

PS&D tables for Fresh and Canned Tomatoes and Tomato Paste have been updated. Production of tomatoes for processing for the 1998/99 marketing year is now estimated at 1,359,300 metric tons. Fresh tomato production for 1998 is estimated at 2,194,000, about 3 percent above the previous year's crop. Area planted to tomatoes for processing during calendar year 1998 was an estimated 24,732 hectares, while 34,752 hectares were devoted to tomatoes for fresh consumption.

During 1998/99, an estimated 1,150,000 tons of fresh tomatoes were delivered to the industry: 170,000 tons were processed into whole peeled tomatoes; about 170,000 metric tons were processed under the category of "Others", with about 50 percent of this quantity made into puree peeled tomatoes ("tomate triturado"; and 810,000 metric tons were processed into tomato paste.

EC Regulation 1518/98, of July 15, 1998 established a minimum price to be paid to producers during marketing year 1998/99 for processing tomatoes as follows:

Minimum grower prices for tomatoes used for paste and other non-peeled processing are adjusted according to total solid content. Aids granted to Spain's tomato sector are limited to the following EU-mandated quotas: f the EU. As in the previous year, the aid granted to Spanish processing operations is limited to the quantities of processed tomato products obtained from the following quantities of fresh tomatoes: tomato concentrate, 664,056 tons; whole peeled tomatoes, 166,609 tons, and other tomato products, 175,799 tons.

Net to raw weight equivalent: paste 0.178 (5.6 to 1); peeled 0.850 (1.18 to 1). Current exchange rate, 1 ECU = 167.25 pesetas, \$1,165; 1 U.S.\$ = 143 pesetas.

Canned tomato exports during marketing year 19997/98 (1996/97 in parenthesis) were 74,497 metric tons (67,305 MT), while imports were only 352 metric tons (162). Tomato paste exports amounted to 50,560 metric tons (39,084 MT) while imports during the same period were 8,966 metric tons (12,194 MT).
