**Report Highlights:**

The U.S.-Japan Trade Agreement (USJTA) entered Year 5 of the agreement implementation on April 1, 2023. This report is one in a series of product briefs highlighting the tariff benefits for specific commodities and products from Year 5 (2023) to Year 7 (2025) of the Agreement. **Overview:** In 2022, the United States exported \$98 million of vegetable preparations (excl. potatoes) and juice to Japan, making Japan its #3 overseas market for these U.S. exports. The United States accounted for 10 percent of Japan’s total vegetable preparations and juice imports. The years below correspond to Japan’s fiscal year beginning April 1.
