## Report Name: Update on Turkey's Export Ban on Select Ag Products

## **Report Highlights:**

This report provides updated information on the status of Turkey's export ban on certain agricultural exports since the beginning of 2022. The government's intent behind the ban is to stabilize the supplies of specific products to help alleviate rising food inflation. The export ban on some products, like olive oil and most vegetable oils, have been lifted. However, a ban remains in effect for select staples, such as red meat, some pulses, and sunflower oil.

## **General Information**

*General Note*: This report provides updated information to earlier reports on Turkey's ban on certain agricultural exports during 2022. For reference, earlier reports on this topic, include: <u>TU2022-0033</u>, <u>TU2022-0026</u>, <u>TU2022-0013</u>, <u>TU2022-0011</u>, <u>TU2022-0008</u>.

Since February 2022, Turkey's Ministry of Agriculture & Forestry (MinAF) has applied an export ban to more than a dozen agricultural products, including vegetable oils, meat, pulses, and some dairy products. The intent behind the ban is to stabilize domestic supplies and alleviate rising food inflation. (Note: humanitarian shipments and products imported for processing and re-export are exempt from the ban.) MinAF has since lifted the ban on some products, such as olive oil and most vegetable oils except sunflower oil. In the case of butter, the ban was replaced with a monthly export quota of 7,000 metric tons (MT) from July-September. Meantime, the latest product to be banned was milk powder, both with fat and skimmed milk powders. The ban on milk powder runs from mid-September until the end of the calendar year.

Turkey has not formally notified any of its export bans to the World Trade Organization. The information below is based on Post's collection of information from various industry and media sources.
