Weekly rice report - BRUSSELS, June 1, 1999

(1) MARKET SUMMARY

Prices in Thailand, United States and EU remain virtually unchanged this week. Thailand's prices maintained their strength due to continued problematic weather. Rains have delayed the second harvest and led to difficulties in transport.

In the United States, the new crop is progressing favorably. Without any big buyers in the market, trade continues at a moderate pace. The Association for the Allocation of Rice Quota has awarded the entire tender of duty-free white rice and reduced-duty brown rice to the EU.

In the EU, the Commission has slowly step up the levels of licences issued at the weekly grain management committee. These licences will be used to facilitate sales to the Middle East and Eastern Europe. Although the new marketing year, and in turn cut in intervention/duties rate, is still 3 months away, traders are beginning to see the downward price pressure reflected in some sales.
