China lowers tariffs on macadamia nuts and pecans in 2015

Report Highlights:

The State Council Duty Committee (SCDC) released its 2015 tariff implementation plan which takes effect on January 1, 2015. This GAIN report contains an unofficial translation of the SCDC announcement, including a table on tentative import tariffs for agricultural commodities. Executive Summary:

The State Council Duty Committee announces its tentative import tariff at the end of each year for selected commodities in the following year. This GAIN report highlights the 2015 changes for agricultural commodities:

Macadamia nuts (in-shell or shelled): The import tariffs for in-shell and shelled macadamia nuts (HS 08026190, 08026200) go from 24 percent (MFN rate) to 19 percent.

Pecan (in-shell or shelled): The import tariff for in-shell and shelled pecan (HS 0802909040) has been lowered from 24 percent to 10 percent.

2015 Duty Implementation Plan

I-Import duties

1-Most Favored Nation Tariff

- 1)-Tentative duties will apply to certain import commodities including fuel oil (see Table 1).
- 2)-Specific or compound duty will continue to apply to 46 commodities including photosensitive materials (see Table 2). For laser phototypesetting films (HS code: 37024321), a 10-percent ad valorem duty will be applied. (Note: refer to this [link](#) for details about the specific or compound duty.)
- 3)-Tariff Rate Quota (TRQ) management will continue to apply to eight categories covering 47 items such as wheat. Tariff rates will remain unchanged (Note: refer to this [link](#) for details about tariff rates under TRQ management). A one-percent TRQ rate will apply to three fertilizers including urea, compound fertilizer, and diammonium phosphate. A sliding tax will be levied on certain amount of out-quota import cotton (see Table 3).
- 4)-Ten non-full tariff code IT products will continue to be managed and verified by the customs (see Table 4).
- 5)-Other MFN duties will remain unchanged.

2-Conventional tariff rates:

Based on trade or tariff agreements signed between China and certain countries or regions, conventional tariff rates will apply to certain countries or regions (see Table 5).

- 1)-Conventional tariff rates under Asia-Pacific Trade Agreement will apply to 1,891 commodities originated from South Korea, India, Sri Lanka, Bangladesh, and Laos;
- 2)-Conventional tariff rates under China-ASEAN Free Trade Agreement will apply to part of the import goods originated from Brunei, Indonesia, Malaysia, Singapore, Thailand, Philippines, Vietnam, Burma, Laos, and Cambodia;
- 3)-Conventional tariff rates under China-Chile Free Trade Agreement will apply to 7,347 commodities originated from Chile;
- 4)-Conventional tariff rates under China-Pakistan Free Trade Agreement will apply to 6,546 commodities originated from Pakistan;
- 5)-Conventional tariff rates under China-New Zealand Free Trade Agreement will apply to 7,358 commodities originated from New Zealand;
- 6)-Conventional tariff rates under China-Singapore Free Trade Agreement will apply to 2,794 commodities originated from Singapore;
- 7)-Conventional tariff rates under China-Peru Free Trade Agreement will apply to 7,124 commodities originated from Peru;
- 8)-Conventional tariff rates under China-Costa Rica Free Trade Agreement will apply to 7,320 commodities originated from Costa Rica;
- 9)-Conventional tariff rates under China-Switzerland Free Trade Agreement will apply to 7,110 commodities originated from Switzerland.
- 10)-Conventional tariff rates under China-Iceland Free Trade Agreement will apply to 7,248 commodities originated from Iceland.
- 11)-Zero tariff will apply to 1,812 commodities originated from Hong Kong, which have formulated origin standards;
- 12)-Zero tariff will apply to 1,315 commodities originated from Macau, which have formulated origin standards;
- 13)-Conventional tariff rates under Economic Cooperation Framework Agreement's Early Harvest Program on Trade in Goods will apply to 622 commodities originated from Taiwan region.

3-Preferential tariff rates:

According to the preferential trade or tariff agreements and bilateral exchange of notes signed between China and other countries or regions, as well as decisions made by the State Council, the preferential tariff rates under the Asia-Pacific Trade Agreement will apply to certain commodities originated from Bangladesh and Laos. In addition, preferential tariff rates of zero will apply to 97 percent of the tariff lines for products originating from 24 countries including Ethiopia, Burundi, Equatorial Guinea, Congo (Congo Kinshasa), Djibouti, Guinea, Guinea Bissau, Lesotho, Madagascar, Malawi, Mali, Mozambique, Southern Sudan, Sierra Leone, Senegal, Sudan, Somalia, Tanzania, Uganda, Chad, Central Africa, Afghanistan, Yemen, and Vanuatu; 95 percent of the tariff lines for products originating from 14 countries including Angola, Benin, Togo, Eritrea, Comoros, Liberia, Rwanda, Niger, Zambia, East Timor, Cambodia, Myanmar, Nepal, and Samoa; and 60 percent of the tariff lines for products originating from Mauritania and Bangladesh (see Table 6).

4-Common tariff rates will remain unchanged.

II-Export duties

Tariff rate under "export tariff" will remain unchanged and tentative tariff rates will be applied to

certain export commodities such as raw iron (see Table 7 for export duties).

III-Tariff codes

Part of the tariff codes have been adjusted (see Table 8). After the adjustments, the 2015 tariff codes include a total of 8,285 commodities.

The above plan takes effect as of January 1, 2015.
