FSSAI Introduces a Food Categorization System

Report Highlights:

On May 11, 2012, The Food Safety and Standards Authority of India (FSSAI) introduced a Food Categorization System (FCS) for all food products covered by the Food Safety and Standards Regulations, 2011. Under the proposed FCS, the FSSAI has classified food products into categories and sub categories, with distinct codes. Some proprietary products are also included. The coding system is based on the Codex structure to promote consistency between domestic and international food standards. It has not been notified to the WTO.

General Information:

On May 11, 2012, The Food Safety and Standards Authority of India (FSSAI) introduced a Food Categorization System (FCS) for all food products covered under Chapter two of the Food Safety and Standards Regulations, 2011. Under the proposed FCS, the FSSAI has classified food products into categories and sub categories, with distinct codes. Some proprietary products are also included. The coding system is based on the Codex structure to promote consistency between domestic and international food standards. It has not been notified to the WTO.

Advantages of Food Categorization System:

- 1. It is based on codex structure which is internationally recognized. CODEX standards are accepted by a large number of countries.
- 2. FCS will provide a scientific basis to the Indian food laws, improving product quality for Indian consumers and International consumers of Indian food.
- 3. The harmonization with other global regulations will promote and facilitate international trade.
- 4. CODEX standards are basis for resolution of WTO trade disputes.
