#### **Report Highlights:**

This report is the unofficial translation of Law 17-88 along with its implementing measures: Decree 2-95-908 and Order 440-01, all of which concern shelf life and maximum storage temperatures. These measures have not been notified to the WTO.

Law No. 17-88 relating to the indication of shelf life on preserved packaged products and packaged beverages, intended for human or animal consumption promulgated by the Dahir N. 1-88-179 of Rabii I 22, 1414 (September 10, 1993);

Considering the constitution, in particular Article 26 thereof, **DECIDED AS FOLLOWS:** 

Is promulgated and will be published in the Official Gazette, following the present Dahir, the <u>Law No. 17-88</u> relating to the indication of the shelf life on preserved packaged products and packaged beverages, intended for human or animal consumption, adopted by the House of Representatives on Chaoual 29, 1408 (June 14, 1988).

# Law No. 17-88 relating to the indication of the shelf life on preserved packaged products and packaged beverages, intended for human or animal consumption

#### **First Article**

The preserved packaged products and the perishable packaged beverages, intended for the human or animal consumption must indicate their date of production and expiration date.

#### Article 2

The period of shelf life shall be carried out on the products referred to in Article 1 by showing the date of production and the shelf life by:

- The day and the month for the products whose shelf life exceeds three (3) months;
- The month and the year for the products whose shelf life is greater than three (3) months without exceeding eighteen (18) months;
- As regards products whose shelf life is longer than eighteen (18) months, the indication of the shelf life which must be apparent on the packaging, the canning or bottle and by legible figures following the production and the expiry dates.

The list of products mentioned above is laid down by Decree, which will determine, if necessary, the special conditions of the product preservation.

#### Article 3

The sale or exposure to the sale of products whose shelf life expired is prohibited.

#### Article 4

Any violation of the provisions of this Law is liable to a fine of 12 to 5,000 dirhams, without prejudice to more serious convictions provided for by specific legislation.

#### Article 5

Infringements of the provisions of the present Law and the texts adopted for its application are sought in accordance with the provisions of the Law N. 13-83 relating to the fraud prevention on the goods promulgated by the Dahir N. 1-83-108 of Moharrem 9, 1405 (October 5, 1984).

#### Article 6

The procedures of application of the provisions of this law are laid down by Decree.

#### Article 7

This law comes into force from the date of its publication in the Official Bulletin.

#### THE PRIME MINISTER,

Considering the <u>Law No. 17-88</u> relating to the indication of the period of validity on preserved packaged products, and packaged beverages, intended for human or animal consumption promulgated by the Dahir N. 1-88-179 of Rabii I 22, 1414 (September 10, 1993);

Considering the <u>Law N. 13-83</u> relating to the fraud prevention on the goods promulgated by the Dahir N. 1-83-108 of Moharrem 9, 1405 (October 5, 1984);

After examination by the Council of Ministers held on Moharrem 2, 1420 (April 19, 1999),

#### Order

**FIRST ARTICLE:** In accordance with the provisions of article 1 of the abovementioned <u>Law No. 17-</u> <u>88</u>, the preserved packaged products, and the packaged beverages, perishable, intended for the human or animal consumption, must bear the indication of their date of production and that of their expiry. For the purposes of this Decree, the following terms mean:

- 1- **Preserved:** Perishable foods of animal or vegetable origin, whose preservation is ensured by the combined use of the two following techniques:
  - Packaging in a container, which is impervious to liquids, gases and microorganisms at any temperature below 55 ° C.
  - Treatment by heat or any other mode authorized by the regulations in force. The purpose of this treatment must be to destroy or totally inhibit, for one part, the enzymes and the other part, microorganisms and their toxins, the presence or proliferation of which may alter the foodstuff in question or make it unfit for human consumption.
- 2- Packaged: Any foodstuff as long as it is prepackaged.
- 3- Foodstuff: Any foodstuff product or drink intended for human or animal consumption.
- 4- **Pre-packaged foodstuff:** The sale unit constituted by a foodstuff and the packaging in which it was packaged prior to its presentation for sale, whether or not this package covers it wholly or in part, but in such a way that the contents can not be modified without the packaging being opened or modified.

**ARTICLE 2:** The list of products referred to in the second paragraph of Article 2 of <u>Law No. 17-88</u> referred to above is fixed in Annex I of this Decree. For these products, the period of validity and, if applicable, the special conditions of conservation, in particular the temperature to be respected, according to which it has been determined are fixed by Joint Order of the Minister of Agriculture and the minister(s) concerned.

For pre-packaged foods not listed in the list of products mentioned above, the date to which these products retain their specific properties under the appropriate conditions is the responsibility of the packer.

**ARTICLE 3:** The special conditions of preservation must be stated by labeling on the products according to the procedures, which will be specified by Joint Decree of the Minister of Agriculture and the minister(s) concerned.

**ARTICLE 4**: The expiration date is expressed on the label in the form:

- a) For the products, appearing on the list referred to in Annex I of this Decree:
  « best before ... » Followed by the date indicated in accordance with Article 5 below.
  It may also be expressed by the reference « to consume until the date appearing... » followed by the place where it appears on the packaging.
- b) For products, not appearing on the list referred to in Annex I to this Decree:
  « to be consumed preferably before... » followed by the date indicated in accordance with Article 5 below.
  It may also be expressed by the reference « to consume preferably before the date appearing....»

followed by the place where it appears on the packaging.

The non-perishable prepackaged foodstuffs listed in Annex II to this Decree are exempted from the indication of the expiry date.

#### **ARTICLE 5:**

The expiry date mentioned above and the date of production provided for in the First Article of the abovementioned <u>Law No. 17-88</u> must be indicated on the packaging and expressed, apparently, in perfectly legible characters, and indelible.

#### **ARTICLE 6:**

This decree shall come into force six months after the date of its publication in the Official Gazette.

- Wines, liqueur wines, sparkling wines, aromatized wines and similar products obtained from fruit other than grapes

- Drinks containing 10% or more by volume of alcohol

- Bakery and pastry products, which by their nature, are normally consumed in the period of 24 hours after manufacture;

- Vinegars

- Kitchen salts

- Sugars in the solid form

- Confectionery products consisting almost solely of flavored and / or colored sugar;

- Chewing gums and similar chewing products

- Individual doses of ice cream

#### Order

**FIRST ARTICLE.** - **The period of validity** (Shelf life) of preserved packaged products and packaged drinks intended for human or animal consumption appearing in Annex I of the abovementioned <u>Decree</u>  $N^{\circ} 2-95-908$  of 18 Moharrem 1420 (May 5, 1999) as well as the temperature of their storage are listed in the table annexed to this order.

**ART. 2.** - In addition to the indication of the date of production, and the expiration date which must be indicated on the packaging in accordance with the provisions of the abovementioned <u>Decree N° 2-95-908</u> of 18 Moharrem 1420 (5 May 1999). The same expiration date followed by the indication of temperature storage, must be clearly expressed and in perfectly legible and indelible characters at the level of the labeling of the products listed in the table annexed to this order.

**ART.3.** – The present order will be published in the Official Bulletin.
