Japan to Increase Butter and Decrease NFDM Imports in 2019

Report Highlights:

On January 30, Japan's Ministry of Agriculture, Forestry and Fisheries announced its intent to import 20,000 metric tons (MT) of butter and 20,000 MT of non-fat dry milk (NFDM) in Japanese fiscal year 2019. This reflects a 7,000 MT increase in planned butter imports from the previous year as food processors ramp up demand for imports, but a 7,000 MT decrease in NFDM imports on weaker than expected demand and higher ending stocks.

General Information:

On January 30, 2019, Japan's Ministry of Agriculture, Forestry and Fisheries (MAFF) announced plans to import 20,000 metric tons (MT) of butter and 20,000 MT of non-fat dry milk (NFDM) for Japanese fiscal year (JFY) 2019, which runs from April 1, 2019 to March 31, 2020. Japan imports certain designated dairy products, including butter and NFDM, through a state-trading system operated by the Agriculture and Livestock Industries Corporation (ALIC). Each year, MAFF sets import volumes based on its analysis of the supply and demand situation in Japan. Import volumes for the previous three years are shown in Table 1 below. Tenders for butter will be held every month and for NFDM every two months.

The butter import volume of 20,000 MT reflects an increase of 7,000 MT from each of the previous two years when MAFF set imports at 13,000 MT. The increase is primarily due to growing demand from food processers. Although MAFF projects domestic butter production to continue trending upward, particularly as southern Hokkaido recovers from the September 2018 earthquake, most domestic supply will be diverted to table use while food processors remain dependent on imported butter supplies. Between August 2018 and December 2018, the average number of Japanese company bids for ALIC butter sales increased from 2.3 to 5.9, reflecting growing demand from processors. It is also likely that MAFF seeks to build sufficient buffer stocks in case of future natural disasters. Ending butter stocks for 2018 are estimated at 20,110 MT, eight percent lower than the previous year.

The NFDM import volume of 20,000 MT for JFY 2019 reflects a 7,000 MT decrease from JFY 2018 and 14,000 MT decrease from two years prior. MAFF had previously ramped up imports of NFDM to meeting growing ingredient demand for milk beverage products and ice cream. However, modest increases in domestic production as well as significant volumes of NFDM entering Japan outside of the designated dairy products TRQ have reduced the need for these imports. Ending stocks for NFDM in 2018 stood at 61,000 MT, up nine percent from the previous year. MAFF projects that the planned import volumes will be sufficient to maintain the domestic supply-demand balance.

Japan's recent imports of butter and NFDM (including imports outside of the designated dairy TRQ) are shown in Tables 2 and 3 below. In 2018, Japan imported 15,532 MT of butter of which 508 MT were from the United States. Japan imported 52,073 MT of NFDM of which 9,550 MT were from the United States.
