The following report was prepared by the Agricultural Trade Office (ATO) in Monterrey, Mexico to inform U.S. exporters that: on Christmas day and New Years day, the National Service of Health, Food Safety, and Food Quality (SENASICA) border inspection offices (OISA's) will modify their working schedule.

General Information:

During the Christmas and New Year Holidays, SENASICA's border inspection offices will operate as usual except on December 24 and December 31, 2013. We recommend exporters to contact their local U.S. freight forwarders, Mexican customs brokers and clients to confirm corresponding operation hours in order to avoid delays at ports of entry.
